

- Page 1. June 12, 1815, Adam Jourdan (signed Jordan) to Moses Gwyn, for \$350.00, 100 acres on Knob Lick Creek. Witnesses Warner Crow and George Handley. Recorded June 12, 1815.
- Page 1-2. August 27, 1805, James Adams and Margaret Adams, wife, of Ohio County, Kentucky to Cecelius Head of Nelson County, for \$150.00, 150 acres in Ohio County on waters of Beaver Creek. Wit. Benj. Duncan, James Smeathers, Nathaniel Beall, and Eli Beall. Recorded June 12, 1815.
- Page 3. May 6, 1815, John Daviess as attorney-in-fact and agent for John Rowan, surviving executor of Joseph H. Daviess, deceased, to John Field, for \$200.00, 200 acres in Ohio County on south side Panther Creek, Pt. of 30,000 acres patented to said decedent. Recorded June 12, 1815.
- Page 3. June 9, 1815, Terry Thorp to James Gentry, for \$450.00, a negro boy called Bob, aged 19. Witnesses James W. Johnson and Henry White. Recorded July 10, 1815.
- Page 4-5. June 24, 1815, Henry White as agent for Richard A. Maupin, to William Roberts, agreement to lease or rent land on waters of Pup Creek and on road leading to mouth of Blackford Creek, pt. of 1000 acre tract, from 1st of January last until last day of December 1824; lessee agrees to put 20 acres in "cultyvation" and to plant 25 apple and 30 peach trees and take care of them, and clear timber where these are planted in two years and to not to make any willful waste of the timber and to use best "indeavers" to prevent others trespassing and not to take in any subtenant; to return the place in tenentable repair. In consideration to pay 1000 bushels of good and merchantable corn after first five years, each year, to be delivered on the premises in November each year. Witnesses Bay'd Duncan and Elisha Adams. Recorded August 7, 1815.
- Page 5. October 6, 1815, Thomas Frields appoints father, Edward Frields, of State of Tennessee and County of Anderson as attorney-in-fact to sell 88 ½ acres of land there. Witness, John Daviess. Recorded October 6, 1815.
- Page 6. September 21, 1815, John Handley, of Greenriver, to Joseph Potts, for \$150.00, 100 acres of land. Witnesses Thos. Bryan and Thomas Penney.
- Page 7. August 14, 1815, James Humphrey Primus, a man of color, to Charles Worthington, for \$100.00, binds himself in servitude for two years from March 10, 1815. Worthington to supply "sufficient coarse clothing and diet." Recorded August 14, 1815.

- 7-8. August 9, 1813, Horatio Chandler, as executor of John Bottom, deceased, of Green County, to James Bates of Ohio County, for 163 pounds, 750 acres on waters of Blackfords Creek. Acknowledged by James Allen, Clerk of Green County. Recorded November 23,1815.
- Page 9. December 15, 1815, John Gabbard (signed Gabbert) to Thomas Jones, for \$350.00. a negro named Dick, aged 25. Recorded December 15, 1815.
- Page 9-10. November 24, 1815, James Bates to Ruben Bates, for \$275.00, 180 acres on waters of Blackfords Creek. Witnesses Charles Y. Duncan, Charles Worthington. Recorded December 14, 1915.
- Page 10. December 21, 1815, Charles Thrift to Barruck O. Thrift, "in consideration of natural love and affection which I have and bear unto my beloved son Barruck O. Thrift of same place" 2 bay mares, saddles bridles, 2 feather beds, one trunk and its contents together with sundry articles of household and kitchen furniture and farming utensils and all and singular personal property which I now own or possess. Witness, William R. Griffith, Clerk. Recorded December 21, 1815.
- Page 11. October 21, 1815, Nicholas Hardin and Mariam, his wife, to Thomas Moseley, Jr., for \$160.00, 100 acres on waters of Buck Creek which Hardin purchased of Benjamin Kirtly and part of Benjamin Roberts 16,250 acre survey. Witness, William R. Griffith, Clerk. Recorded December 25, 1815.
- Page 12-13. December 23, 1815, James Trotter for himself and for other heirs of Joseph Trotter, deceased, to John May, lease of 400 acres for six years, including plantation and farm where John May now resides, part of 2000 acre survey, including improvements made by Daniel Pinkston on which John Barnhart resided, rent to be one peck of corn. If May is ever evicted due to superior title, he is to have value of improvements he has made, and when that title is cleared, to have first refusal at price of woodland. Recorded December 23, 1815.
- Page 13-15. December 12, 1815, John Rowan of Nelson County, executor or trustee of estate of Col. Joseph Hamilton Daviess, etc., to Joshua Griffith; whereas Daviess in his lifetime, on December 4, 1807, executed his bond to Griffith binding himself to make to said Joshua a deed to 500 acres on the road from Shoemakers to Glenns, being same land which Benjamin Fields once viewed with said Daviess and Griffith and which land was to be laid off in the manner prescribed in said bond, and whereas by a survey Certificate herewith annexed, it appears the land was intended to be conveyed to said Griffith by Daviess, for \$500.00 in the form of a bond, 500 acres, part of Daviess' 30,000 acre survey. Original Certificate by J. H. Daviess was witnessed by Walter McFarland and Robert Wall. Recorded December 12, 1815.
- Page 15. May 14, 1816, Charles Duncan, Sr., in consideration of natural love and affection for grandson to Charles Y. Duncan, a negro girl named Kitty, about 8 years old, now in possession of Mrs. Peggy Adams. "Reserved right and use until death and she is not to be taken out of my possession while I live unless with permission." Recorded May 14, 1816.

Page 16. October 20, 1815, Moses Martin to William Wilcher, for \$60.00, whereas Edward Martin of County of ____ State of Virginia, died leaving Moses only surviving heir, all right and title to estate both real and personal which his father possessed at time of death in Virginia. Recorded January 6, 1816.

Page 17. December 28, 1815, Edward Haydon and Joseph Atwill, merchants trading under name of Haydon and Atwill appoint James M. Rogers as attorney-in-fact to conduct business in State of Kentucky and in Indiana Territory, to receive debts, and to rent or sell houses and lands. Witness, William R. Griffith and John Seman [sic, Leman]. Recorded December 29, 1815.

Page 18-19. October 16, 1815, Nicholas Dorsey, late of Baltimore, and at present of Louisville to Carter Beaman of Jefferson County, Kentucky, for 56.00 620 acres in Daviess County, except 100 acres which was sold to Emanuel Taylor by deed October 5, 1815, part of 1000 acre survey described in deed from Elizabeth Dorsey to said Nicholas March 26, 1812, recorded in the Clerks Office of the General Court of Kentucky. Witnesses, Craven T. Luckett, Isaac Clark, Floyd. Certified in Jefferson County December 5, 1815, recorded in Daviess County December 30, 1815.

Page 19. September 2, 1814, John Travis, for value received from Samuel Hancock of Ohio County, all right to claim for services and horse furnished in U. S. Army as mounted volunteer under command of Captain James Tyler in Col. Philip Barbours Regiment on a tour to Lake Erie, August 19, 1813 to November 14, 1813, the whole commissioned by his excellency Isaac Shelby. Witness, John Beeler, William R. Griffith, recorded January 11, 1816.

Page 20. January 15, 1816, Peter Coffee of Ohio County appointed attorney-in-fact of Samuel Hancock to receive of Paymaster of 10th Regiment of Kentucky Mounted Volunteers all due as a private in Captain James Tyler's Company of Militia attached to Col. Philip Barbours Regiment in the expedition to upper "Canady" in 1813 under command of his excellency Isaac Shelby. Recorded January 15, 1816.

Page 20-21. January 8, 1816, William McFarlin, Jr. and William Glenn, executors of estate of John McFarlin, deceased, to Frances McFarlin, widow of said John, whereas Frances has renounced the provisions made in and by the last will and testament of deceased husband, said executors agree that widow shall have use of Negores devised to her, and in addition thereto William Glenn and wife, by capacity as executor, transfers his right to the Negro boy in said will, named Johnston. William McFarlin does likewise and further agrees he will procure from other heirs release of their interest in Johnston, those over age within six months, and those under age six months after the day they become of age. Executors also agree that one horse, saddle, riding chair, and \$250.00 cash mentioned in a receipt dated May 9, 1815 shall remain in possession of said widow as her absolute property. Executors further agree widow to receive 500 pounds good merchantable pork, 100 bushels good merchantable corn, six common chairs, 6 knives and forks, one cupboard of equal quality to the one now in the dwelling house of the late John McFarlin, deceased, also two cows worth \$10.00 each, 4 head of sheep, one large kettle, one pot, one tea pot, one spice mortar, one large earthen dish, 6 plates, one square table, half of the geese on the farm, the cotton now in the possession of the widow, 1/2 of the flax on the farm. Also any demands of the said John McFarlin against Abner Lee, son of the said widow, shall be considered settled except a book account of \$30.00. The above shall be full settlement, and Frances agrees to dismiss motion made this day, and receives the above in lieu of dower. Recorded January 8, 1816.

Page 22. January 9, 1816, David Clover and William McFarland, Jr., in consideration of love and affection to Dice McFarland and John McFarland, who are grandchildren of the said David Clover and children of the said William McFarland, Negroes, a woman named Jenny and her four children named Fanny, Armstead, Easter and Amos, all in possession of William McFarland who reserves use and of increase until son John, who is now about 11 months old, shall arrive at age 21. Recorded January 5, 1816.

Page 23-24. January 25, 1816, Henry White, and Polly, his wife, to Thomas Clay, whereas William C. Gault and Matilda A. Gault sold to Henry White and Thomas Clay by deed December 14, 1812, 200 acres on Pup Creek waters of the Ohio River, part of land patented in name of John May, 15,000 acres, and conveyed by John L. May, Daniel Eppes and Polly, his wife, to Norborne B. Beall William C. Gault, and Matilda, his wife, and Matilda Maupin, heirs of Samuel Beall, deceased. Polly relinquishes dower. Recorded January 25, 1816.

Page 24-25. January 31, 1816, John Duncan and Nancy, his wife, to Hezekiah L. Priest and John H. Priest, for \$16.00, land on Beach Fork of branch of Pup Creek, being part of a tract conveyed by Henry White to John and Nancy Duncan. Recorded January 31, 1816.

Page 25-27. August 21, 1815, James Beard, High Sheriff of Ohio County, to Eli Adams and Elisha Adams, whereas on April 16, 1810, there was issued from Nelson County Circuit Court a writ of execution to the Sheriff of Ohio County to make \$103.08 debt and 0.33 costs which John D. Strother had recovered against Eli Adams, Sr., James Adams and Thomas Meloy, to be discharged by payment of \$51.54 cash with interest and costs. Debt was levied against 200 acres of James Adams, which he gave up to satisfy said execution, levied by James Johnston, acting deputy sheriff for Thomas Moseley, then High Sheriff of Ohio County. Land was on waters of Pup Creek. Said land was advertised for sale June 22, 1810 and sold to Eli Adams, Jr. and Elisha Adams for \$17.00, and is now conveyed, James Johnston having failed to convey land while he was in office. Recorded February 7, 1816.

Page 27-28. February 24, 1816, Cecelius Head and Elizabeth, his wife appoint William B. Head of Frederick County, Maryland attorney-in-fact purposes whereas Tobias Butler, father to Elizabeth Head died intestate in Maryland, and to attend to the settlement of the estate. Recorded February 24, 1816.

Page 28-29. October 5, 1815, Nicholas Dorsey to Emanuel Taylor, whereas by deed dated March 26, 1812, Elizabeth Dorsey deeded to Nicholas Dorsey 100 acres of a tract of 620 acres. Recorded in Book D, in General Court Clerk's Office, Frankfort, Kentucky. Witness Joshua Griffith and Elizabeth Griffith. Recorded February 17, 1816.

Page 29. July 4, 1815, Walter Calloway of Ohio County appoints William Hedge of Daviess County attorney-in-fact "to sign my name to the payroll of the 13th Regiment of Kentucky Militia commanded by Col. Daviess in the detachment commanded by Major General John

- Thomas, and the receipt for my pay as a private in the Company of Captain William Gannaway." Witness, P. Thompson, Chesley Calloway, Jr., and John Field. Recorded March 6, 1816.
- Page 30. March 9, 1816, Thomas Clay and Mary, his wife, to Synthia Green Clay McCreery, for \$1.00, land on Pup Creek. Witness, James W. Johnson, George Medcalf. Recorded March 25, 1816.
- Page 31-32. March 28, 1816, William C. Gait and Matilda A., his wife, of Louisville, to henry White, for \$43.00, 21 ½ acres on main branch of Pup Creek, certified in Jefferson County March 28, 1816, including relinquishment of dower March 30, 1816. Recorded April 8, 1816.
- Page 32. March 10, 1816, Benjamin Field to Thomas Morgan, for \$75.00, 75 acres. Recorded April 8, 1816.
- Page 33-34. April 7, 1816, John Daviess, agent and attorney-in-fact for John Rowan, executor of Joseph H. Daviess, deceased, to Robert McFarland, for \$100.00, 100 acres on south side of Panther Creek. Recorded April 8, 1816.
- Page 34. October 2, 1804, Thomas Moseley, Sr. and Mary, his wife, of Ohio County, to James Smith of Ohio County, for 31 pounds, 3 3/4 acres on waters of Green River, money to be refunded, if evicted. Wit. George Ashby, John Gibson. Recorded April 8, 1816.
- Page 35. January 3, 1816, James Hollenhead to James Gentry, whereas Hollenhead is indebted to said Gentry in the sum of \$435.00, and to secure his debts, sells to Gentry one Negro boy Jack. Wit. Charles Dorsey, Jr., Tom Moseley, Jr. Recorded April 30, 1816.
- Page 35-36. May 9, 1816, Thomas Clay and Mary, his wife, to Robert McCreery, for \$5.00, land in Caldwell County, pt. of 1000 acres granted to Clay by the Commonwealth of Kentucky July 22, 1795, on south side of Cumberland River. Recorded May 9, 1816.
- Page 37. April 2, 1816, Charles Duncan, in consideration of \$100.00, has "released from slavery, liberated, manumitted and set free my negro man named Peter Curry, being of the age of fifty five years and able to work and gain a sufficient livihood and maintainance." Wit. Benjamin Duncan, Charles Y. Duncan. Recorded May 13, 1816.
- Page 37-39. May 11, 1816, Memorandum of agreement from Samuel Handley of Nelson County to George Handley and Remus Griffith, whereas John Handley, late a resident of Daviess County, has died, possessed of considerable property, and there being many lands in dispute, and sundry suits now pending on validity of land claims, and dying intestate. This indenture witnesseth that the said Samuel Handley, who is a son of said decedent and entitled by inheritance to a child's portion, has sold all his interest and claim to estate. George Handley and Remus Griffith bind themselves to convey or caused to be conveyed to Samuel Handley as soon as practicable, 4000 acres of the land which was possessed by John, to lie in Daviess or Ohio Counties, to be equal in quality to the land usually sold by John Handley, deceased, at \$2.00 per acre, and also agree to pay Samuel Handley \$661.70 and to deliver one negro man named Dublin of value of \$600.00. Wit. Joseph D. McFarland, Bannister Wall. Recorded May 13, 1816.

- Page 39-40. May 14, 1816, Isaac Whayne and Polly C., his wife, to Walker Pruett of Louisville, for \$285.50, part of 1000 acres, part of 15,000 acre tract of John May on the Ohio River, including at the mouths of Blackfords and Pup Creek. Recorded May 25, 1816.
- Page 40-41. May 25, 1816, John Bates, Sr. of Jefferson County, to John Bates, Jr. of Jefferson County, for \$20,000.00, that tract on which John Bates, Sr. now lives on the Ohio River in Jefferson County, 625 acres, as by deed of partition with James S. Bates; right, title, claim and interest of which John Bates, Sr. has with heirs of James Morrison, deceased, including land which "layes" in several counties as well as the lots in the town of Louisville. Recorded May 25, 1816.
- Page 41. December 6, 1815, James Jordan, Jr., William Locke, Jonas Spray appoint James Rogers attorney-in-fact to sign their names to payroll of 13th Regiment Kentucky Militia commanded by Col. Davies under the command of Gen. Thomas in the late expedition to New Orleans, to receive all pay due. Wit. Charles Dorsey, Jr., William R. Griffith and Morris B. Snyder. Recorded December 6, 1815.
- Page 43-44. December 2, 1814, John Handley of Green River to Reymus Griffith of Ohio County, for \$5.00, land in Ohio County, north side of Green River, 10 miles below Vienna, part of 20,109 3/4 acres granted to James Morrison and John Handley dated June 2, 1787, where Arnold Taylor now lives, 500 acres. Wit. Elijah Crowe, Alexander Moore and David Eastwood. Recorded July 30, 1816.
- Page 42-43. December 2, 1814, John Handley of Green River to Reymus Griffith of Ohio County, for \$5.00, land in Ohio County on Panther Creek, 500 acres, pt. of land patented to said John Handley on .June 9, 1802 of 4000 acres. Wit. Elijah Crowe, Alexander Moore and David Eastwood. Recorded July 30, 1816.
- Page 44-45. July 23, 1816, John Yories, formerly of Hopkins County, appoints Daniel Dulin of Ohio County as attorney-in-fact to receive all pay due as a service in the 14th Regiment of Kentucky Militia under command of Col. Parker in the expedition to New Orleans, as a private soldier in Capt. Alney McLean's Company of said regiment under command of Major General Thomas. Recorded July 23, 1816.
- Page 45. August 14, 1816, Amos Critchfield, of Warrick County, Indiana to William Beaty of Daviess County, a negro man named Bob, aged about twenty-two, for \$524.00. Wit. Charles Dorsey, Jr. (Clerk). Recorded August 14, 1816.
- Page 45-46. August 15, 1816, John Meeks of Warrick County, Indiana appoints. John Bery of Knox County, Indiana attorney-in-fact to "call upon and receipt to the paymaster of the spies under the command of Major Duboy in General Hopkins campaign" for pay due him in Captain William Smeathers Company of spies. Wit. Charles Dorsey, Jr., Clerk. Recorded August 15, 1816.
- Page 46-48. July 30, 1816, Norborne B. Beall and Anne N., his wife, of Jefferson County, to Richard Taylor of Shelby County and Jacob Shaw of Daviess County, for \$1150.00, 1300 acres,

pt. of land granted to John May of 15,000 acres April 23, 1787, which land conveyed by John L. May and Polly Eppes, late Polly May, and Daniel, her husband, as heirs of John May, deceased, and Anne Lewis, deceased, late Anne May, to Norborne B. Beall, Matilda A. Gait and Matilda A. Maupin by deed November 18, 1812, recorded in General Court, Frankfort. This has since been conveyed to Norborne B. Beall by William C. Galt, Matilda A. Galt, his wife, and Richard A. Maupin on behalf of himself and his infant daughter Matilda A. Maupin. Recorded in Jefferson County July 30, 1816, and in Daviess County August 28, 1816.

- Page 48-50. August 5, 1816, Richard Taylor to Jacob Shaw, for \$1.00, 700 acres as described in the preceding deed, on waters of Blackford Creek. Wit. James Moore, George Henry Shaw. Recorded August 28, 1816.
- Page 50-51. George Statelor appoints nephew George Statelor, a citizen of the state of Ohio, attorney-in-fact, whereas "I, George Statelor, son and devisee of Stephen Statelor and Susanna, his wife, who was erroneously called by the name of Stephen Stradler, late of the State of Pennsylvania, am the sole owner and legally entitled to the whole of my father's real estate by his last will and testament." Mentioned Will was in Pennsylvania. Had land in Virginia on waters of Potomac River. Wit. William R. Griffith, Clerk. Recorded September 9, 1816.
- Page 51-52. August 13, 1816, Thomas Smith, of Ohio County, to William Coomes, Smith being indebted in the amount of \$253.12 1/2 as a result of a loan, is willing to secure payment by means of this instrument, in conveying a negro woman, Ann, aged 25, who is to remain in Coomes possession twelve months and if not paid at the end of that time, to become property of Coomes. Recorded August 13, 1816.
- Page 52. August 7, 1816, Personally appeared before John Memon, a justice of the peace, Mary Potts and "made oath that the words that is stated she should have said concerning Mary Smeathers having had a yellow child or a black child is erroneous and false, that she never did say the words above spoken and that she never knew any harm of her in that respect in her life." Recorded August 7, 1816.
- Page 52-53. August 30, 1816, Henry Winkler appoints Thomas Vandaver attorney-in-fact for purpose of settling with "the Duncan" Sheriff and to draw the money which is due him from James Hollenhead. Acknowledged before Justices of the Peace Benjamin Duncan and Amos Riley. Recorded September 9, 1816.
- Page 53-54. Samuel Handley of Nelson County appoints George Handley and Remus Griffith attorneys-in-fact for settlement of John Handley estate. Wit. Bannister Wall, Joseph D. McFarland, and John Handley. Recorded October ?, 1816.
- Page 55. May 3, 1812, John Rowan and James Meed, trustees of the late Col. Joseph Hamilton Daviess, appoint John Daviess, Esq., attorney-in-fact to do "whatever in relation to the estate of the said decedent we might or could do." Wit. James Morrison. Acknowledged in Mercer County, Kentucky before Thomas Allin, Clerk, June 3, 1812, recorded in Daviess County October 17, 1816.

Page 55-56. October 15, 1816, Robert Wall to Thomas McGehee of Person County, N.C., for \$150.00, land in Person County derived from last will and testament of Claude Muirhead, deceased, an undivided 1/9th. Wit. William R. Griffith and Joseph D. McFarland, Recorded October 15, 1816.

Page 57. October 19, 1816, Charles Y. Duncan, Sheriff of Daviess County, to Thomas Montgomery of Lincoln Co., as per execution of writ in name of William Carson and William Smith, administrator of the estate of Stephen Langford, against estate of John Cockran and Jane, his wife, late Jane Crow, John Thompson and Ann, his wife, late Ann Crow, John Crow, Elijah Crow, Jesse Crow and Benjamin Crow, children, heirs of John Crow, deceased, for 224 pounds and \$22.94 1/2 and \$16.28 court costs dated August 3, 1816. Levied on part of a 6000 acre survey in Daviess County patented in the name of the heirs of John Crow, part being in Breckinridge County. Recorded October 19, 1816.

Page 58. November 7, 1816, "The foregoing memorial of deeds recorded in Clerks Office of the Court of Appeals of this State was this day exhibited to me in my office and admitted to record, November 7, 1816." - Lands lying in Daviess County subsequent to the 9th day of August 1815 and prior to 29th day of June 1816. August 10, 1815 William Taylor, executor, to John Wilcox 500 acres, Panther Creek, patented to Haptenstall. September 24, 1815, John Wilcox to William Taylor, 500 acres, Panther Creek, patented to Haptenstall. October 21, 1815, Hubbard Taylor to Frances P. Hord, et al, 7000 acres, Panther Creek, patented to Taylor

Page 58-59. April 1, 1814, Joseph Arnold of Muhlenberg County, and Hannah, his wife, to William Glenn, of Ohio County, for \$250.00, 103 1/2 acres, part of 420 acres sold by John Handley to said Arnold, in Ohio County, on "Delleware Creek," a branch of Green River. Wit. William Faith, John Williamson, and James Hobbs. Recorded November 2, 1816.



Page 61. October 19, 1816, John Rowan of Nelson County, surviving executor of the estate of Col. Joseph H. Daviess, deceased, to Robert Duncan, for \$550.00, 150 acres on Yellow Creek. Wit. James W. Johnson and Charles Y. Duncan. Recorded November 13, 1816.

Page 62. August 26, 1816. Rachel Handley, of Madison County, Territory of Illinois to Remus Griffith. Rachel formerly married to and lived with a John Handley, deceased, but voluntarily eloped from her said husband about the year 1792 and both lived out of the said state since that period, now sets up claim to the estate as widow. Remus Griffith contends she has no claim, but to quit claim, pays her \$1,000.00 and she relinquishes interest and she agreed to set aside the power of attorney previously given to John Wallace. Wit. William R. Griffith and George Handley. Recorded September 13, 1816.

Page 63-64. March 23, 1816, Plat recorded of Rossboro, proposed to be established at the Yellow Banks, at request of George Handley. Recorded and approved December term. William R.

Griffith appointed agent on behalf of the County to enter into a division of the lots with the Proprietors. Recorded December 30, 1816. Approved Frankfort January 7, 1817 as laid off by James W. Johnston, surveyor, on the appointment of agent, George Handley. (Signed) David Ross, by his agent, Thomas Lewis, John L. May, Daniel Epes and Polly Epes, by L. L. May, attorney-in-fact, John F. May, by L. L. May, attorney-in-fact, and John Wilder, by L. L. May, attorney-in-fact.

Page 65-66. December 10, 1816, Willis Odum appoints Edward Bacon, Esq. attorney-infact, a citizen of Edgefield County, S. C. for purpose: Milly Mash, deceased, late wife of Samuel Mash, of Edgefield County, is entitled to considerable estate and whereas Willis Odum, brother of Milly Mash, deceased, is to take possession of this property. Wit. John Davis, Meredith Cox. Recorded December 10, 1816.

Page 66-67. January 13, 1817, John Mothrel to William Glenn, for \$200.00, 100 acres. Wit. Tom Moseley, Jr. and David Leman. Recorded January 28, 1817.

Page 67. January 31,1817, James Hollenhead sold to Benjamin Yager a negro boy, William, age about 14, of yellow complexion, "to be void as soon as Yager shall be discharged

and acquitted from the payment of \$212.00 which he has executed his bond for to Mason Jones payable at New Years day 1818 and which money said Hollenhead has received, said Yager being security for the money. Boy is to remain in possession of Hollenhead." Wit. William R. Griffith. Recorded January 31, 1817.

Page 68. February 22, 1817, Eli Adams, Jr. to Elisha Adams of Nelson County; parties have 200 acres in Davies County conveyed to them at sheriff's sale August 21, 1815 and Eli sells to Elisha his share for \$125.00. Wit. William R. Griffith. Recorded February 22, 1817.

Page 68-70. February 24, 1817, Charles Y. Duncan, Sheriff to Thomas Meloy, as per writ of execution July 20, 1816 by Daviess County Circuit Court, writ commanded Sheriff that of the estate of William Adams, Eli Adams, Elisha Adams, Jane Adams, Peggy Adams, Susanna Adams, Polly Adams, Betsey Adams, William Head and Hannah, his wife, late Hannah Adams, heirs of James Adams, deceased, should cause be made of \$170.00 with interest from August 27, 1805, and \$12.80 costs which Benjamin Duncan lately in said Court had recovered against said heirs by virtue of judgment at July 1816 term; executor levied September 7, 1816 on that part of the 4000 acres survey patented in name of Samuel Oldham lying on Pup Creek which belonged to said heirs, and which remained after the satisfaction of a certain execution in favor of William H. Woolsey. This sale pertains to purchase by Thomas Meloy of 226 acres for \$83.62 September 23, 1816, Recorded February 24, 1817.

Page 70. January 28, 1817. Thomas Moseley, Jr. and Sally C. Moseley, wife, to Remus Griffith, for \$90.00, two parcels on Buck Creek, land Moseley had purchased of Nicholas Hardin. Witness, William R. Griffith, clerk.

Page 70-71. March 1, 1817. Sally C. Moseley was examined and relinquished her dower. Witness, Wm. R. Griffith, clerk. Recorded.

Page 71-72. March 3, 1817. James Parker and Susanna, his wife, to Reuben Brown and Joshua Brown, for valuable consideration, 2 tracts, 500 acres, part of Benjamin Roberts 16,250 acres on waters of Buck Creek. Witness, Thomas W. Watkins, William R. Griffith. Recorded March 3, 1817.

Page 72-74. March 3, 1817. Charles Y. Duncan, Sheriff of Daviess County, to Elisha Adams. On writ of firi facias, from clerk's office of Daviess County, dated May 6, 1816, directed to the sheriff, commanding him that of the estate of William Adams, Eli Adams, Elisha Adams, William Head and Hannah, his wife, late Hannah Adams, Jane Adams, Peggy, Susanna, and Elizabeth Grey Adams, heirs at law of James Adams, deceased, that he should cause to be made \$115.00 plus interest of 6% from April 9, 1810 until paid, to be levied on the lands of the said James Adams, which William H. Woolsey lately recovered in the Daviess Circuit Court. Also the sum of \$13.50 costs. The land, being part of 4000 acre tract on waters of Beaver Creek, now called Pup Creek, patented in the name of Samuel Oldham, being the part unsold and remaining, which was advertised to be sold on July 6, 1816, and said land being unsold for want of bidders. Under the new Court order, land was advertised September 23, 1816, and agreeably to law, Eli Adams being the highest bidder, was awarded 420 acres for \$183.71. Recorded March 3, 1817.

Page 74-75. October 26, 1816. William C. Galt and Matilda, his wife, of Jefferson County, Kentucky, to Elijah McCreery of Christian County, for \$400.00, land on Pup Creek in Daviess County, part of tract of 15,000 acres patented in name of John May lying on the Ohio River, including the mouth of Blackford and Pup Creeks, being two lots of 1000 acres each, designated and known on the plat of division between the heirs of Samuel Beall, deceased, as Nos. 13 and 18. Recorded October 26, 1816, at which time Matilda Galt was separately examined and relinquished her dower.

Page 76-77. February 22, 1817. Joseph D. McFarland and Robert McFarland, two of the Commissioners appointed by the Daviess County Circuit Court, to Lucy McFarland. Whereas by judgment of the Daviess County Circuit Court at July term 1816, the said Joseph D. McFarland, Meredith Cox and Robert McFarland were appointed to sell and to convey all the right and title of the heirs of Walter McFarland, deceased, for 200 acres, which land was duly exposed to sale by advertisement, and Lucy McFarland was the highest bidder for \$270.00. Witness, William R. Griffith, Clerk. Recorded April 7, 1817.

Page 78. June 9, 1817. Charles Y. Duncan to Joseph Grigsby. Whereas said Grigsby was erecting a water grist mill on Yellow Creek in Daviess County adjoining the said Duncan's land, and Duncan herewith sells to Grigsby two acres of land out of the 100 acres where he now resides. Recorded June 9, 1817.

Page. 79-80. July 8, 1817. Samuel B. Handley and wife (unnamed), Remus Griffith and Sally, his wife, late Sally Handley, and George Handley, heirs to John Handley, to Josiah H. Yager, of Hardin County. Whereas that John Handley in his life time to August 20, 1795, by his certain writing obligatory, bound himself to convey to John Reed 600 acres on road leading from Vienna to the Yellow Banks, which said bond has by legal transfer become the property of the above named Josiah H. Yager, and land is therefore and herewith deeded in accordance with law. Signed, Samuel Handley, by George Handley, his attorney-in-fact, Remus Griffith, Sally Griffith, and George Handley. Recorded July 16, 1817.

Page 81-82. July 7, 1817. William Everley and Polly, his wife, to Warner Crow, land for \$100.00. Recorded July 7, 1817.

Page 82-83. April 17, 1817. William R. Griffith as Commissioner to Benjamin Duncan. Whereas by decrees issued by the Ohio County Circuit Court at the September 1816 term in a suit in chancery, between William Bell, adm. and Nancy Bell, adm. of Nathaniel Beall, deceased, v. Eli Adams, Sr. and the heirs and legal representatives of James Adams, deceased. William R. Griffith and Charles Y. Duncan were appointed as commissioners to sell certain tracts to satisfy the judgment, and having duly advertised and exposed to sale, Benjamin Duncan became purchaser as highest bidder. Witness, Tom Moseley, Jr., Jo Allen, Ch. Henderson. Certified by the Ohio Circuit Court April 17, 1817 by Charles Henderson, Clerk. Recorded in Daviess County, July 17, 1817.

Page 84-85. July 7, 1817, John Rowan, surviving executor of the estate of the late Col. Joseph Hamilton Daviess, by his attorney-in-fact John Daviess to George Handley and Remus Griffith. Whereas Joseph Hamilton Daviess in his lifetime executed certain writing obligatory to

John Handley who has since died, for the conveyance of 1500 acres, which is filed in Breckinridge County Circuit Court, and said John Handley instituted an action of covenant which is revived in names of George Handley and Remus Griffith, administrators of John Handley estate, assigning to George Handley and Remus Griffith 1100 acres in Daviess County on Panther Creek. Recorded July 7, 1817.

Page 85-86. July 8, 1817, John Rowan, as surviving executor of the estate of Col. Joseph Hamilton Daviess, dec'd to John Kennady, for \$1200.00, tract of land in Daviess County on Ohio River about two miles below the Yellow Banks, including the premises where John Kennady now lives, 300 acres, being part of 1000 acre tract owned by the estate of the late Joseph Hamilton Daviess. Recorded July 8, 1817.

Page 87-88. July 5, 1817, Charles Y. Duncan, sheriff of Daviess Co. to William Beall, as a result of a writ of execution issued by the Clerk of the Jefferson County Circuit Court dated May 28, 1817, commanding the sheriff of Daviess County that of the estate of Charles L. Campbell and Coleman Daniel, there should be made \$228.82 which Levi Taylor had recovered in Court on a debt on a replevy bond, also \$0.92 costs, with interest of 6% since 28th December 1816, said debt to be discharged by payment of \$114.41. Judgment was levied on June 2, 1817 on a tract of 400 acres which had been patented in the name of Arthur Campbell, on Ohio River, in Daviess County, just above the mouth of Yellow Creek. Land included where the widow Beall lived. Reference is made to patent dated November 8, 1796. Land was given up by Charles L. Campbell for purpose of being sold to satisfy the debt, advertised June 28, 1817 at the house of Mrs. Beall, and William Beall was highest bidder at \$161.00. Recorded July 5, 1817.

Page 88-89. June 10, 1817, Joseph Allen of Breckinridge County, Samuel Work of Warren County, and Moses Cummins of Ohio County, to Christopher Decker [sic, Dicken]. Whereas on August 14, 1815, Benjamin Gilbert, then sheriff of Ohio County, conveyed to Allen, Work and Cummins 500 acres lying on the Long Falls of Green River, and including the town or part of the town of Vienna, by virtue of a sale made by said Gilbert as sheriff against the estate of said Decker, at which sale Allen, Work and Cummins became the purchaser for \$5.00. And whereas the said Decker has paid the \$5.00 to the purchasers, they relinquish title to Decker. Witnessed as to Samuel Work by P. Thompson. Moses Cummins acknowledged before Charles Henderson, Clk. of Ohio County Court June 10, 1817. Recorded July 7, 1817.

Page 90. Bill of Sale from William E. Files of Daviess County to Thomas H. Files of Muhlenburg County, for five head of horses, being one large bay mare, 16 years old, one gray mare, 7 years old, one bay horse, 7 years old, one black horse, 2 years old, one iron-gray horse colt, 1 year old, also 9 heed of cattle, 2 bulls four or five years old, 3 milch cows, two yearlings and two calves, all marked with a smooth crop of the left ear and an upper slope and slit in the right; also 46 head of hogs, old sows, yearlings and pigs being of the same ear marks, and likewise all corn and tobacco which "1 now have on my plantation," all farming utensils, one axe, one weeding hoe, one shovel plow, and all household furniture, three head of sheep, all for \$500. Witness, John Files. Recorded August 5, 1817.

Page 91-92. August 25, 1817. Simon Wheelock and William Savage of Madison County, Territory of Illinois, to George Handley and Remus Griffith. Whereas Simon Wheelock

intermarried with Hetty Handley, daughter of Rachel Handley, formerly wife of John Handley, deceased, who set up claim as an heir of John Handley to a portion of his estate, and whereas Simon and Hetty have sold one-half of their claim and interest to said Savage. Now Handley and Griffith have deemed it advisable to quiet the claim of Simon and Hetty. Simon and Hetty state that for \$1250.00 paid to them by Handley and Griffith, they convey all their right and claim on the estate of John Handley, dec'd, and whereas the said William Savage sometime in 1816 purchased of Rachel Handley one-half of her dower right, and whereas Remus Griffith on August 26, 1816 also purchased of Rachel Handley her dower right to the estate of John Handley, dec'd, Savage now ratifies and confirms the sale by Rachel Handley to Remus Griffith. Witness, Lewis Odom. Recorded August 25,-1817.

Page 92-93. September 5, 1817. John Galloway and Robert McCreery, two of the commissioners appointed by Daviess County Circuit Court for the division and sale of non-resident lands, to John Churchill, Senior. Whereas Charles Chelton died possessed of two tracts of 1250 acres each, patented to him on April 7, 1786, on the south side of Panther Creek, and whereas John Chelton, son and heir, by indenture dated July 12, 1804, sold to George Jones 252 1/2 acres. And whereas on July 11, 1812 George Jones sold to George Rust the same 252 1/2 acres, with bond annexed, and bond was assigned September 23, 1814 to John Churchill, whereby he holds equitable title to the 252 1/2 acres. The Commissioners were called on by Churchill, and also by Richard A. Buckner, the attorney-in-fact for the heirs of Charles Chelton, to divide the land into six equitable lots, being the number of heirs of the decedent. After the Commissioners examined the property, in the company of the County Surveyor, and Churchill, land was divided into six lots, lot no. 1 being 326 acres, lot no. 2 being 300 acres, lot no. 3 being 350 acres, lot no. 4 being 350 acres, lot no. 5 being 350 acres and lot no. 6 being 450 acres, the land divided according to its quality. Churchill having drawn with the said Buckner for choice lot, drew lot no. 4 and this lot no. 4 was transferred by this deed.

Page 94-95. July 12, 1804. John Chelton of Westmoreland County, Commonwealth of Virginia to George Jones, of Fauquier County, Commonwealth of Virginia, for 250 pounds 10 shillings, 252 1/2 acres of land on Panther Creek in Daviess County, Kentucky. (see preceding deed). Witnessed by Batewell Chelton and Jeremiah Muse. Acknowledged September 24, 1804 in Fauquier County Court, and recorded Daviess County, Kentucky September 5, 1817. Recorded Fauquier County October 23, 1810.

Page 95. July 11, 1812. George Jones of Gallenton County (note: Gallatin County), Kentucky to George Rust of Hardin County, 252 1/2 acres on Panther Creek in Daviess County (see the two preceding deeds). Witness Ellis Hambleton and Barbary Hambleton. Bond assigned to John Churchill September 23, 1814. Witnessed by Sam Stevenson. Recorded September 5, 1817 in Daviess County by John Galloway and Robert McCreery, Commissioners.

Page 96. August 12, 1783. Philip Philips and Thomas Cunningham gave bond to Daniel Brodhead for 2000 pounds Virginia currency as executors and administrators. Whereas Philips sold to Brodhead three tracts of land on the head waters of Cany Creek, a branch of Rough Creek "which empties into Green River" and bond was to assure title. Witness; John Tibbs and G. Calhoun. George Calhoun appeared before the Clerk of the County Court and made oath the bond was signed in his presence. Recorded August 1817.

Page 97. September 6, 1817. John Churchill, Sr. of Hardin County to William Glenn of Daviess County, for \$500.00, a tract in Daviess County on the waters of Panther Creek, entered, surveyed and patented in the name of Charles Chelton and conveyed to Churchill by the Commissioners of Daviess County, being 350 acres. Recorded September 8, 1817.

Page 98-99. October 20, 1817. James Hobbs and Hannah, his wife, to William Faith, for \$280.00, 100 acres, a part of 400 acres sold by John Handley to Joseph Arnold and by Arnold to Hobbs, on the waters of Delaware Creek, being part of a 1500 acre tract which was patented to said Handley. Witness, William R. Griffith. Recorded October 20, 1817.

Page 99-100. September 8, 1817. Indenture, William R. Griffith, Clerk of Daviess County Court, to Jesse Crow, in obedience to order of said Court at their June term 1817, in that William Anderson, orphan of Athel Anderson dec'd ("who on the 10th day of March 1822 will arrive at the age of 19 years") after the manner of an apprentice, to dwell with and serve the said Jesse Crow (husbandman) until he reaches age 19. Anderson to serve Crow and Crow will instruct Anderson in his trade as husbandman, to teach him reading, writing and common arithmetic "including the rule of three" and at the age of 19 shall pay Anderson 3 pounds 10 shillings in cash and provide him with a new suit of clothes, and to provide and clothe him in the meantime. Witness, J. Calhoun. Recorded September 9, 1817.

Page 101-102, November 1, 1817, between Jacob Shutt of Muhlenburg County and Remus Griffith of Daviess County, whereas Jacob Shutt executed a bond for conveyance of 2 acres to Nicholas Walker on March 12, 1790, the said land having been sold to Shutt by Jacob Huff by deed recorded in Frederick County, Maryland on June 18, 1780, and whereas Nicholas Walker was killed by Indians in May 1790 leaving Sally Walker his only child and infant heir, and whereas Sally Walker in 1810 married William Young and she died October 30, 1817, the land is assigned and transferred to Remus Griffith, claimant. Now in consideration of 5 shillings, Jacob Shutt sells and conveys to Remus Griffith the land known as the resurvey on the hope and anchor, land being in Frederick County, Maryland on a road that leads from Frederick Town toward the mouth of Conococheaque and on the South side of Ketochen[?] Creek, land having been conveyed to Jacob Huff by Andrew Flickinger. Witnessed by Robert Wall, Lewis Odom and William Daniel. Indenture was proven in Court by oaths of Robert Wall and William Daniel on November 10, 1817, and ordered certified to Frederick County.

Page 103-104. October 4, 1817. John Howel of Ohio County, Kentucky, to Remus Griffith of Daviess County, whereas Henry Ambrose, son and heir to Jacob Ambrose, late of Frederick County, Maryland, dec'd, on February 27, 1779 deeded in trust to Ludwick Kemp a tract called good neighbor as was returned in the certificate of resurvey under the third vacancy which by agreement of Jacob Ambrose, in his lifetime with Peter Shover, is to be conveyed to Shover, 486 acres; another tract called center bit, 12 acres; a tract called Charming Beauty, 25 acres, all being in Frederick County, Maryland, said tracts to be sold by Ludwick Kemp at the death of Catherine Ambrose and proceeds to be divided among all the surviving sons and daughters of Jacob Ambrose equally. And, whereas, Jacob Ambrose, one of the sons of Jacob Ambrose, dec'd, did on March 12, 1803 sell his interest to John Howel; now John Howel, for valuable consideration, sells such interest and title to Griffith, and should said land have been sold according to the intentions of the

deed of trust, Griffith is authorized to recover from any person said money for this portion. Witnessed by William Daniel, Robert Wall, and at a County Court on November 10, 1817, said indenture ordered to be recorded and certified to Frederick County, Maryland.

Page 105-106. November 10, 1817, Benjamin Gibbs and Mary, his wife, of Washington County, Kentucky, to Jacob Crow of Mercer County, whereas Benjamin Gibbs and William Crow agreed to purchase and sell the said Gibb's undivided moiety of 1500 acres lying near the Long Falls of Green River, patented to Edward Cook and the said Gibbs executed his bond to a David Lewis for the other moiety of the said 1500 acres, which lands Jacob Crow now holds by assignment. Witnessed by Thomas J. Crawford, William Stirman, and _____ Pitts. Mary Gibbs was examined and relinquishes her dower. Recorded Washington County on December 6, 1817, and in Daviess County February 6, 1818.

Page 107-108. November 10, 1817. John Rowan, surviving executor of the estate of Joseph Hamilton Daviess, dec'd, to Joseph Grigsby of Daviess County for \$1170.00, land on Yellow Creek, 390 acres, including the plantation where Grigsby now resides, bounded by land of Joseph Thompson, the bank of Yellow Creek, and the junction of the north fork of Yellow Creek. Signed by John Daviess, attorney-in-fact for John Rowan. Recorded November 10, 1817.

Page 108-109. November 29, 1811, Charles Duncan of Ohio County, for the natural love and affection for his grandchildren, the sons of his son Rolly Duncan, dec'd, to-wit: William Duncan, Willis Duncan, George Duncan and John Duncan, three Negro slaves. Witnessed by Benjamin Duncan and William Smith. Proved in Daviess County Court by Benjamin Duncan and William Smith December 8, 1817.

Page 109-111. March 21, 1817. Norborne B. Beall and Ann P. Beall, his wife, of Jefferson County, to Polly C. Haywood, William Bartlett, Samuel E. Bartlett and Nancy Bartlett of Daviess County, for \$255.00, 255 acres, part of a tract granted to John May of 15,000 acres patented April 23, 1787, said land conveyed by John L. May and Polly Eppes and Daniel, her husband, heirs and devisees of John May, and Ann Lewis, late Ann May, to Norborne B. Beall, Mabel A. Gall and Matilda Maupin on November 12, 1812, recorded in the General Court of the Commonwealth and said tract of 255 acres was sold to Norborne B. Beall by William C. Gott [sic, Galt] and Matilda A. Gott, his wife, and Richard A. Maupin on behalf of himself and his infant daughter Matilda Maupin, by indenture. Witnessed by Worden Pope, clerk; Signed as Norborne B. Beall and Ann B. Beall. Certificate by Worden Pope, Clerk of County Court of Jefferson County, March 21, 1817, and recorded in Daviess County February 16, 1818.

Page 111-112. February 4, 1818. John Beeler and Elizabeth, his wife, of Nelson County to James Ritchey of Daviess County for \$400.00, land in Daviess County which was conveyed by John Handley to William Beelor and by him to John Beelor, bounded by John Mossley's land; 150 acres. Witness, William R. Griffith. Recorded February 4, 1818.

Page 113-114. January 27, 1818. William Beeler and Nancy, his wife, of Warren County, Kentucky, to John Beeler of Nelson County, for \$150.00, land in Daviess County conveyed by John Handley of Green River to said William Beeler [see preceding deed]. Witness, William R. Griffith. Certified by William R. Griffith in Court, as Clerk, January 31, 1818.

Page 114. March 25, 1818. For \$85.00, William Odom sold to John Field three head of horses, to-wit, one brown horse, one spotted mare, and one bay colt "2 years old this Spring", and one cow and calf. "The said John Field leaves the said property in my hands until he shall think proper to remove them and I will deliver them to him, or he may take them wherever found as I hold said property only under a Loan during the pleasure of said John Field." Witness, Nelson Mason and John Duncan. Recorded March 25, 1818.

Page 115. April 6, 1818. James Bates and Mehethelene Bates, his wife, to Jessee Lockett, for \$450.00, land on Blackford Creek in Daviess County, being part of a tract conveyed from the executor of the estate of John Bottom to said Bates, 110 acres. Recorded April 6, 1818.

Page 116. March 13, 1818. John Fields of Daviess County appointed William Fields of Henderson County his attorney-in-fact to sell lands in Tennessee, in the counties of Morgan and Roan. Witness, John W. Moseley and John Roberts, Jr. Certified by William R. Griffith as Clerk, April 7, 1818 on oath of 30hn W. Moseley.

Page 116-117. March 27, 1818, Enoch Anderson and Nancy, his wife, to John L. Stutson (all being of Daviess County), for \$100.00, land in the Territory of Illinois in the tract of lands appropriated by an Act of Congress for military bounties, 160 acres, said land having been granted to Anderson February 16, 1818 by the President of the United States. Witness, William R. Griffith. Certified by Griffith who examined Nancy Anderson separately and transmitted to Territory of Illinois for recording, April 11, 1818.

Page 118-121. Whereas certain propositions were made by the proprietors of a 3000 acre tract patented in the name of May and Ross, situated on the Yellow Banks in Daviess County, dated October 28, 1815, to the commissioners who were appointed to select a place for the seat of justice for the County, said proposition now being of record, in the office of the Clerk, and said were accepted by the Commissioners on November 11, 1815, as appears by their report of record, and County Court did, at December term 1816 appoint William R. Griffith their Agent to make a division of the lots of a town which had been laid off in such a proposition, now called Owensborugh, the plat now being of record, said division being dated January 8, 1817, that when required, conveyance would be made to Benjamin Duncan, John Daviess or Davis, and other acting Justices of the County Court or to Commissioners for that purpose appointed by said Court, the right to title which the proprietors held, to the lots which by said division fell to said County, and also to the Public Square of 2 acres and the streets designated on the aforesaid plat. Said County Court at the March term 1817 appointed William R Griffith and Thomas Moseley, Jr. as Commissioners, authorizing them to receive a conveyance from the Proprietors. Therefore, this indenture dated October 24, 1817 between John C. May, Daniel Eps and Mary, his wife, formerly Polly May, the said John and Polly being the only children, heirs at law and devisees of John May, dec'd, and also the only children and heirs of Ann Lewis, dec'd, who was Ann May, widow, and sole acting executrix of the last Will and testament of said J. May, dec'd, and John F May and John Wilder claiming jointly by purchase of said Eps and wife one undivided fourth part of the interest of said Mary Eps in the land belonging to the estate of her deceased father and mother, to Benjamin Duncan, John Davis and other acting Justices of the Peace composing the County Court of Daviess County, said land heretofore described. Streets named were Front or Main Street, 2nd Street, 3rd

Street, 4th Street, Lewis Street, Daviess Street, Allen Street, St. Ann Street, Frederica Street, Elizabeth Street, Locust Street, Mulberry Street, and Walnut Street. Signed by John C. May and John Wilder by John C. May, their attorney-in-fact. Certified by William R. Griffith November 11, 1817.

Jno BANISTER, now dec'd, sold ½ of his interest to David R ROSS, who also purchased the lands of Kennon JONES (also dec'd), and that Kennon JONES left heirs: Robt K. JONES, Kennon JONES & Haxall JONES. Christopher MCCONNICO sold his interest to Thos SHORE, but this same land was transferred to David ROSS with SHORE maintaining mortgage, and that a chancery court in Richmond, Va. awarded Robt K.
