
Whitsell Family of Slaughters, KY

Christopher Dean Whitsell

Christopher Dean Whitsell, the son of Kenneth Earl Whitsell (1948-1992) & Patricia Ann Walker (1950-), was born in 1970 at the Hopkins County Hospital in Madisonville, Hopkins County, KY. He married Christy Michelle Long and they have three children – Kenneth Taylor, Kaylee Linda and Kyle Joseph. The family of Christopher Whitsell resided about two miles from Slaughters in Webster County, KY. For over 140 years seven generations of his family has lived in the vicinity of where the town of Slaughters is now located. The following outline traces each successive generation of Chistopher's Whitsell line of descent.

Generation 1


The <u>Dictionary of American Family Names</u> (2nd edition, 2022) states that the Whitsell surname is an Americanized form of the German Weitzel or Witzel. The progenitor of the Whitsell family of Slaughters, KY is **George Whitsell**, who during 1784-1821 had been a resident of Wilkes and Oglethorpe Counties, Georgia.

The 1800 and 1820 census records suggest that George Whitsell was born during 1755-1763. He died in 1821 in Oglethorpe County, Georgia.

A 200 acre survey was entered in the name of George Whitsel on 15 August 1784 in Wilkes County, GA.

George Whitsell also appears in: the 1785 tax list of Wilkes County, GA; 1790 census of Franklin County, GA; 23 August 1790 Wilkes County, GA jurors list; 1796, 1798 & 1805 tax lists of Oglethorpe County, GA, and 1800 & 1820 censuses of Oglethorpe County, GA. Oglethorpe County, Georgia had been created out of Wilkes County, GA on 19 December 1793. It was named for General James Edward Oglethorpe, who founded the colony of Georgia, at Savannah, in 1733 as an asylum for British debtors. The first permanent white settlers that settled in Georgia after the Revolutionary War were a group of wealthy tobacco planters from Virginia.

In Oglethorpe County, GA George Whitsell purchased 200 acres on Clouds Creek on 19 June 1809; 77 acres on Clouds Creek on 17 July 1811; and 27 acres on Clouds Creek in September 1817.

George Whitsell, Sr. married Elizabeth Crowley about 1794. She was the daughter of Benjamin Crowley & Sarah Strong. Elizabeth appears to have died during 1796-1800. In the listing for the home of George Whitsell in the 1800 Oglethorpe County, GA Census no adult female was listed, suggesting that George's wife, Elizabeth, was then deceased. On 9 February 1801 George married Elizabeth Meadows in Oglethorpe County, GA.

George Whitsell wrote his final will on 22 November 1820 and it was recorded on 9 March 1821 in Oglethorpe County, GA (will book A, pages 185-187). Numerous pages of accounts in the settlement of his estate, including an inventory of his estate, were filed in the Oglethorpe County, GA estate files (can be viewed on the internet site familysearch.org).

Oglethorpe County Georgia. Will book B, pp.185-187:

In the Name of God Amen. I, George Wliltsell, Sen'r' of Oglethorpe County and State of Georgia being weak of body, but of sound mind and memory and knowing that it is appointed for all men once to die do make publish and declare this to be my last will and testament, revoking and disannulling all former wills heretofore made by me. Principally and first of all, I commend my soul to Almighty Cod in hopes of its gracious acceptance with him and my body I resign to the Earth to be buried in a decent manner – and as for such worldly estate wherewith it hath pleased God to bless me in this life, I give and dispose of the same in manner and form following.

First my will and desire is that out of my estate all my just debts be paid.

Secondly. I give and bequeath unto my daughter, Polly Simmons during her natural life one negro boy named Aquilla, one negro boy named James Mitchell and the sum of thirty dollars cash if that sum should be left after the payment of all my just debts and the legacies contained in this will

Thirdly I give and bequeath unto my daughter Martha Whitsell one negro man named Asa one negro girl named Cynthia one feather bed and furniture one sorrel horse named Ball one saddle

and bridle of the value of twenty five dollars one good cotton wheel and cards one cow and my side board and dressing table

Fourthly. I give and bequeath unto my daughter Sally Edwards one negro girl named Sarah and one negro man named Stephen.

Fifthly. I give & bequeath unto my son James Whitsell one negro woman named Betty and her child Emeline one negro boy named Sam one feather bed and furniture one cow and that half my tract of land where on I now live to him and to his heirs forever but should he die without lawful issue I desire that his part of my land may be equally divided between George Whitsell and John Whitsell and the other part of his legacy is to be sold in the family and to be equally divided between Polly Simmons Martha Whitsell, George Whitsell and Sally Edwards

Sixthly. I give and bequeath unto my son George Whitsell one half of the tract of land contained in the survey where on my improvements are which I purchased of Matthew Clendennin having respect to quantity as well as quality to be equally divided between James Whitsell and George Whitsell also one negro girl named Alley one negro boy named Osborn one feather bed and furniture and one cow

Seventhly I give and bequeath unto my daughter Curacy Upshaw one negro woman named Hannah and her child Washington one black colt named Rock and the sum of thirty dollars cash if that sum should be left after the payment of all my just debts and the legacies contained in this will

Eight1y I give and bequeath unto my son John Whitsell my tract of land in Madison County containing two hundred acres adjoining John Ross' survey on the waters of Blacks Creek one negro man named Cump (?) one feather bed & furniture one black colt named Ranter one negro boy named William and one cow and my will and desire is that his negro man Cump should be hired out and the money arising from his hire to be appropriated in giving my son a good English education at the discretion of my Executors

Ninthly If any balance or residue should remain after payment of my just debts and the legacies contained in this will I desire that the sum of two hundred & twenty six dollars may be applied in building a good hewed log house on the north east end of the tract of land whereon I now live for my son George Whitsell.

And lastly I do nominate constitute and appoint my friend William M. Stokes and my son George Whitsell Executors of this my last will & testament In testimony whereof I have hereunto set my hand & affixed my seal this twenty second day of November in the year of our Lord one thousand eight hundred and twenty.

Interlined before assigned, the words, & one negro boy named Sam.

It is not clear if all of the children of George Whitsell, Sr. were by his wife, Elizabeth Crowley, or not.

Children of George Whitsell, Sr.:

- Mary Whitsell, "Polly" was born c1792 GA and died after 1870. Married John Simmons (c1789-after 1870), 22 December 1807 Oglethorpe County, GA. She is listed in the 1850, 1860 & 1870 censuses of Cherokee County, GA.
- 2. Martha Whitsell was born 1794-1804 GA and died in 1822 in GA. She was not married. She wrote a will on 16 January 1822 and it was recorded in Oglethorpe County, GA in May 1822.
- Sarah Whitsell, 'Sally", was born c1795 GA and died after 1860; buried Edwards Cemetery, Henry County, GA. Married Littlebury ("Little") Brittain Edwards (1792-1827), 21 November 1814 Oglethorpe County, GA and John M. Ponder, (1795-1864), 27 November 1827 Oglethorpe County, GA. She is listed in the 1850 & 1860 censuses of Henry County, GA.
- 4. James Whitsell was born in March 1795 GA and died in September 1858 in KY; buried Whitsell Cemetery in Webster County, KY. He is listed in the 1830 & 1840 censuses of Hopkins County, KY and 1850 federal census of Henderson County, KY. The 1850 Henderson County, KY Slave Schedule recorded that he owned 9 slaves. Married Ann (Crews) Reynolds (1795-1839), 13 November 1823 in Hopkins County, KY. On 30 July 1858 James Whitsell wrote a will and it was recorded in Henderson County, KY Will Book C (pp.157-158). In his will he named the following children: James F. Whitsell, Perry J. Whitsell, Sarah Stull's heirs, Ann Stull, Nancy S. Orsbon, Elizabeth F. Brackett and Emily J. Sugg. James & Ann's children included:
 - a. Sarah Whitsell was born c1825 KY and died 1850-1852. Married James S. Stull (c1821-), 24 March 1842 Hopkins County, KY. In the 1850 Henderson County, KY census listed after the household of her father.
 - b. Ann Whitsell was born c1826 KY and died after 1880. Married her brother-in-law, James S. Stull (c1821-), 5 January 1852 Henderson County, KY. In 1880 she was residing in Webster County, KY.
 - c. John G. Whitsell was born 3 May 1827 KY and died 12 July 1858; buried Whitsell Cemetery, Webster County, KY. His brother-in-law, Robert A. Sugg, was appointed the administrator of his estate on 16 July 1858 in Henderson County, KY.
 - d. James F. Whitsell born c1829 KY and died after 1870. Married Sarah A. Tompkins, 12 January 1854 Hopkins County, KY.

- e. Perry J. Whitsell was born 27 October 1830 KY and died 1 March 1863; buried Whitsell Cemetery, Webster County, KY. Married Catherine Gates, 28 October 1858 Henderson County, KY
- f. Nancy Sidney Whitsell was born 23 July 1832 in Hopkins County, KY and died 8 February 1901; buried Petersburg Cemetery, Sebree, Webster County, KY. Nancy S. married John Wesley Orsburn (1828-1902) on 24 April 1851 Henderson County, KY. Children: Arbella Alice (1852-1931), Mary Frances (1853-1927), Anna C. (1855-1943), Lynn B. (1857-1887), Sarah Florence (1858-1939), Fredonia Estela (1862-1941), Luke T. (1862-1892), Elbert L. (1865-1866), John Goodloe (1866-1924), Charles M. (1868-1895), William Randall (1871-1940) and James Marion (1873-1892).

Kentucky: A History of the State, W. H. Perrin, J. H. Battle & G. C. Kniffin, 2nd ed., 1885, Webster County section:

JOHN W. ORSBURN was born in what is now Webster County, Ky., July 5, 1828, son of Randolph and Frances (Mooney) Orsburn. He is one of a numerous family and is of Scotch-Irish descent. His father was a North Carolinian, born in Rutherford County, October 13, 1795, and his mother was born in the same county in 1799. The Orsburns came originally from Scotland. Subject's father emigrated from North Carolina to Henderson County Ky., in 1818, and died in 1868. The mother of our subject died four years before his father's death. Mr. Orsburn, on coming of age, began farming for himself, and has since continued that occupation, save a short time when he resided in Sebree. His farm, which is one of the finest in Webster County, is located about three miles west of Sebree, and contains 550 acres. He was married April 24, 1851 to Miss Nancy S. Whitsell, a native of Hopkins County, Ky., born July 23, 1832. The Whitsell family came from Georgia. To Mr. and Mrs. Orsburn have been born eleven children: Arbelia, Mary F., Anna C., Lynn B., Sallie F., Donia E., Luke T., John G., Charles M., William R., and James M. Mr. and Mrs. Orsburn are members of the Christian Church. For fifty-six years, Mr. Orsburn has resided near where he was born, and is one of the few men, now living, who have resided in Webster County for more than a half century. He is a Democrat.

- g. Elizabeth F. Whitsell was born c1835 Hopkins County, KY and died during 1860-1867. Married William L. Brackett (1833-1907), 30 May 1853 Henderson County, KY. In 1860 she resided in Webster County, KY.
- h. Roger D. Whitsell was born 11 February 1837 KY and died 10 September 1852 Henderson County, KY; buried Whitsell Cemetery, Webster County, KY. A record

of his death was recorded in the 1852-1861 Kentucky Vital Statistics – which recorded that he was 16 years old; the cause of death was entered as "salivated".

- i. Emily J. Whitsell was born 7 January 1839 KY and died 13 September 1895; buried Old Salem Cemetery, Robards, Henderson County, KY. Married Robert A. Sugg (1829-1909), 17 July 1854 Henderson County, KY.
- George Whitsell, Jr. was born c1796 Oglethorpe County, GA and died 1860-1870 Webster County, KY. Married Elizabeth Lester, 23 August 1820 in Oglethorpe County, GA. She was born c1803 in Oglethorpe County, GA, and died between 1843-1850.
- 6. John Whitsell was born 1804-1810 GA and died after 1833. He was named in his father's will in 1820. In 1833 he sold land in Oglethorpe County, GA.
- 7. Clarresy Whitsell born 1794-1803 and died after 1820. Married Haston Upshaw (1800-1848), 23 November 1817 Oglethorpe County, GA.



Generation 2

George Whitsell, Jr. (George Whitsell, Sr. 1) was born c1796 Oglethorpe County, GA and died 1868-1869 Webster County, KY. Married Elizabeth ('Betsy') Lester, 23 August 1820 Oglethorpe County, GA (marriage book A, page 77). She was born 1803 in Oglethorpe County, GA and died 1840-1843. Elizabeth was the daughter of Lewis Lester (c1760-1822) & Rhoda Russell. Lewis Lester by his will left two slaves to his daughter, Elizabeth Whitsell (Oglethorpe County, GA Will Book B, p.214).

George Whitsell is listed in the 1830 census of Oglethorpe County, GA. George Whitsell, of Oglethorpe County, GA on 6 August 1830 sold to Lewis Lester 320 acres on Clouds Creek in Oglethorpe County, GA for \$550 (deed book N, pp.205-206). During 1830-1834 George moved his family to Kentucky settling near where the town of Slaughters is now located. On his arrival in Kentucky the area was then part of Hopkins County. George's brother, James Whitsell, by 1823 had made Hopkins County his home. George is enumerated in the 1840 & 1850 censuses of Hopkins County, KY. On 29 February 1860 the new county of Webster was formed out of parts of Henderson, Hopkins and Union Counties, KY. On 12 June 1860 George Whitsell & family were listed in the census of the new county of Webster.

No wife is shown with George Whitsell in the 1850 or 1860 censuses. His wife Elizabeth died during 1840-1843. He married Huldah Coffman (1818-1894), 22 February 1843 Hopkins County, KY. Hulda was the daughter of Isaac Coffman & Mary A. Harbour. George & Huldah Whitsell separated during 1844-1850; they had a son, Andrew Jackson Whitsell. Huldah married Gottlieb Schied, 21 January 1856 Hopkins County, KY. Huldah died 9 August 1894 and was buried in the Slaughters Cemetery, Slaughters, Webster County, KY.

George Whitsell also married Elizabeth Eastwood (c1803-1859), 19 June 1851 Hopkins County, KY, and Sarah Buchanan, 14 March 1861 Dixon, Webster County, KY. Elizabeth (Eastwood) Whitsell died of dropsy in September 1859 in Webster County, KY. The 1861 marriage recorded that George was 61, born in Georgia, and it was his fourth marriage. George Whitsell had no children by his last two marriages.

The 1850 Hopkins County, KY Slave Schedule reported that George Whitsell was the owner of 10 slaves – five males and five females, ranging in ages from 1 to 35. By 1852 he was the owner of 16 slaves. The 1860 Webster County Slave schedule reported that he owned 11 slaves. Six of his sons served in the Confederate army during the Civil War defending the right to own slaves.

George Whitsell on 17 April 1837 purchased 500 acres on the east fork of Deer Creek in Hopkins County, KY from Alfred A. Morris, of Richmond, VA; the purchase price was \$1,000 (Hopkins County, KY Deed Book 8, pp.95-96). The land was part of a 4,000 acre military land grant issued on 6 February 1795 to Bernard Lipscombe. At the time the land was purchased in 1837 it was located in Hopkins County, but after 1860 it lay in Webster County. The Hopkins County tax lists thru 1855 show that George was assessed taxes on 500 acres on Deer Creek; beginning with the 1856 tax list he was assessed on 450 acres.

The town of Slaughters in the southeast part of Webster County near the Hopkins County line was laid out on a portion of George Whitsell's 500-acre survey. The town was surveyed and platted in 1857. On 7 May 1857 George Whitsell began selling lots in the "proposed town of Slaughtersville" – a series of deeds were recorded in Hopkins County, KY Deed Book 21 whereby George Whitsell sold town lots. The town was named for Gustavus Greene Slaughter (1833-1918); a tobacco merchant, who bought three lots in the new town. A post office named Slaughtersville was established on 29 January 1856 and the town was incorporated on 4 April 1861. The name of the town was frequently spelled as Slaughterville. The post office was renamed Slaughters in 1915. A street in Slaughters was named Whitsell Street in honor of Albert Louis Whitsell (1922-1999), a great-great-grandson of George Whitsell, Jr. The 2020 federal census counted 190 inhabitants in the town of Slaughters.

George Whitsell was last found in the 1868 Webster County, KY tax lists, he was then taxed on 250 acres; also found in the 1868 Webster County tax list were George Whitsell's sons, Pleasant W., Jacob J. & Prior L. In Webster County, KY Order Book 1 (p.567) on 15 February 1869 it was ordered that the land of George Whitsell, deceased, be surveyed and the dower of his widow, Sarah Whitsell, be allotted to her. In October 1869 to settle the estate of George Whitsell the remaining lands he owned at his death were sold by his heirs.

Children of George Whitsell Jr. and Elizabeth Lester are:

1. John Lewis Whitsell was born in 1823-1824 in Georgia and died on 28 February1871 in Lowndes County, Mississippi; buried Friendship Cemetery, Columbus, Lowndes County, MS. He is listed as "Jno. L." in the household of George Whitsell in the 1850 census of Hopkins County, KY. "Jno." is an abbreviation for the name of John. John L. Whitsell is listed in the 1845-1851 tax lists of Hopkins County, KY. He is not found in the subsequent census records for Hopkins or Webster County, KY. In the 1868 tax list of Webster County, KY it is recorded that Jacob J. Whitsell, incurred additional taxes as an "agent for J. L. Whitsell". This is probably Jacob's brother, John L. Whitsell, who was then a non-resident. This suggests that John L. Whitsell, son of George, was still living in 1868. By 1856 John L. is living in the state of Mississippi. John L. Whitsell married Mary A. Fulgham on 26 August 1856 in Lowndes County, MS. John L. Whitsell, who was born circa 1823 in Georgia appears in the 1860 & 1870 censuses of the state of Mississippi. In the 1860 census he was in Lowndes County, MS; he was reported to be 38, born Georgia, was a farmer and in his home were Mary, 30, born Alabama, Elizabeth 2 & George, 1, both born Mississippi. The 1860 Lowndes County, MS Slave Schedule recorded that he was the owner of 6 slaves. John L. is listed as "John Lewis Whitsell" in the U.S., Confederate Soldiers Compiled

Service Records, 1861-1865. He served as a sergeant in the Confederate army during the Civil War (company G, first State Troops, Mississippi Infantry). He enlisted in the state of Mississippi on 18 August 1864 at the age of 41. John L., son of George Whitsell, had five brothers, who being slave owners from the deep South, also served in the service of the "Lost Cause". In the 1870 census he was enumerated in Oktibbeha County, MS - he was then listed as John L. Whitsel, age 47, farmer, born Georgia, living with him was George R. Whitsel, 11, born MS. In Lowndes County, MS on 14 April 1871 Thomas W. Scott was appointed administrator of the estate of John L. Whitsell, deceased, late of Lowndes County. The probate records of Lowndes County show that John L. Whitsell died on 28 February 1871, his wife had died about 12 months earlier; he left two minor children -Elizabeth (Bettie) J. (c1858-after 1877) and George Robert Whitsell (c1859-after 1877). Mr. & Mrs. Thomas W. Scott an uncle & aunt of the children were appointed their guardian. John Lewis Whitsell was buried in the Friendship (Odd Fellows) Cemetery, at Columbus in Lowndes County, MS. His wife, Mary A. Whitsell, has a gravestone in the same cemetery - it records that she was "born on 2 October 1831 in Limestone, County, Alabama and died on 16 November 1869 in Oktibbeha County, MS."

- William George Whitsell was born 13 October 1826 GA, and died 13 March 1879; buried Slaughters Cemetery, Slaughters, Webster County, KY. He is listed in the 1850, 1860 & 1870 censuses of Hopkins County, KY. In 1860 he was the owner of one slave. During the Civil War he enlisted in the Confederate army at Hopkinsville, KY on 9 October 1861 for a term of one year – company A, 8th Infantry Regiment. He was captured on 16 February 1862 at Fort Donelson in Tennessee and sent to Camp Morton P.O.W. camp at Indianapolis, Indiana; and on 11 September 1862 he was sent Vicksburg, MS for prisoner exchange. Married Margaret Frances Crews (1835-1931), 5 June 1851 in Henderson County, KY. They had 10 children: George Williamson (1853-1944), John Phillip (1855-1888), James Monroe (1857-1928), Margaret Elizabeth (1859-1904), Sally Ann (1862-1939), David W. (1863-1941), Nancy Catherine (1865-1955), Martha J. (1868-1869), Henry Powell (1869-1876) and Andrew Jackson (1873-1876).
- Pleasant William Whitsell was born 15 January 1830 Oglethorpe County, GA and died 29 December 1894 in Webster County, KY; buried Slaughters Cemetery, Slaughters, Webster County, KY. Married Susan Crowley, 27 February 1850 Hopkins County, KY and Mary Ann Fowler 6 November 1856 in Hopkins County, KY. Mary Ann was born 22 July 1834 in Granville County, NC and 23 August 1872 in KY.
- 4. Jacob Joseph Whitsell was born in July 1834 Hopkins County, KY and died 15 August 1909 Evansville, Vanderburgh County, IN; buried Locust Hill Cemetery, Evansville, IN. He is listed with his father in the 1850 Hopkins County, KY census. In the Hopkins County tax lists he was first found in 1856. In 1860 he was the owner of one slave. During the Civil War he enlisted in the Confederate army at Hopkinsville, KY on 9 October 1861 for a term of one year company A, 8th Infantry Regiment. He was captured on 16 February 1862 at Fort Donelson in Tennessee and sent to Camp Morton P.O.W. camp at Indianapolis, Indiana; and on 11 September 1862 he was sent Vicksburg, MS for prisoner exchange. He is listed in the 1860, 1870 & 1880 censuses of Webster County, KY; no children appeared in his household in these three censuses. He married Sarah C. Joyner, 12 November 1857

Henderson County, KY; Sarah was born 30 November 1835 and died 11 February 1884; buried Slaughters Cemetery, Slaughters, Webster County, KY. Jacob J. Whitsell married second Sarah E. Gray (1867-1930), 10 December 1884 Webster County, KY. They are listed in the 1900 census of Texas County, MO. Pleasant William Whitsell (George Whitsell, Jr. 2, George Whitsell, Sr. 1) was born 15 January 1830 Oglethorpe County, GA and died 29 December 1894 in Webster County, KY; buried Slaughters Cemetery, Slaughters, Webster County, KY. Pleasant is listed in the 1850 & 1860 censuses of Hopkins County, KY and 1870 & 1880 censuses of Webster County, KY. In 1850 he was living with his father. He first appears in the Hopkins County, KY tax lists in 1850. He was a farmer and owned his own farm.

The 1860 Hopkins County, KY Slave Schedule reported that he owned one slave – a 12 year old male. Pleasant was one of 6 brothers who served in the Confederate army during the Civil War. He enlisted at Hopkinsville, KY on 9 October 1861 for a term of one year – company A, 8th Infantry Regiment. Four of his brothers, William G., Jacob J. and Prior L. and Andrew J., also enlisted on the same day. All five brothers were prisoners of war; they were captured on 16 February 1862 at Fort Donelson in Tennessee and sent to Camp Morton P.O.W. camp at Indianapolis, Indiana; they were sent to Vicksburg, MS for prisoner exchange on 11 September 1862. On 2 December 1862 Jacob J., Prior L., Pleasant W. and William G. Whitsell were reported to have deserted. After being exchanged they possibly thought that their initial term of one year that they had signed up for was over and they returned home. Pleasant's brother, Andrew Jackson Whitsell while serving in the army was killed at Jackson, MS on 10 July 1863.

On 29 February 1860 Webster County, KY was formed from parts of Henderson, Hopkins and Union Counties. For several years after the creation of Webster County Pleasant W. Whitsell continued to reside in its neighboring county of Hopkins. In 1867 Pleasant was first found in the annual tax lists of Webster County, KY; he was then taxed on 166 acres.

Pleasant W. Whitsell married Susan Crowley, 27 February 1850 Hopkins County, KY. In the 1850 census Pleasant & Susan (age 18) were listed in the home of his father, George Whitsell. Susan was born c1830 Hopkins County, KY and died of intermittent fever on 8 October 1855 in Hopkins County, KY; she was a daughter of Henry & Emily Crowley, who were married in 1828 in Henderson County, KY. 



History of Kentucky, Volume II, Lewis Collins & Richard H. Collins, Covington, KY, 1874, p.755, entry on Webster County:

WEBSTER county, established in 1860 out of parts of Henderson, Hopkins, and Union counties, was the 109th in order of formation; and was named after Daniel Webster, one of the greatest of American orators, statesmen, and lawyers. It is situated near the center of the middle-western portion of the state; has over 292 square miles of territory; and is bounded N. by Union and Henderson counties, E. by Daviess, s. E. and S. by Hopkins, S. W. by Crittenden, and W. by Union county....

Slaughterville, named after an old settler there, G. G. Slaughter, is on the E., H., and N. railroad, near the Hopkins county line; has 4 stores, 3 taverns, 1 church, 3 physicians, 3 tobacco factories, and is a thriving place; incorporated April 4, 1861; population in 1870, 130.

<u>Kentucky Place Names</u>, Robert M. Rennick, The University Press of Kentucky, Lexington, KY, 1984, p.273:

Slaughters (Webster): This 6th class city with post office lies just west of US 41 and 9 ¹/₂ miles east of Dixon. According to local tradition, it was named for Gustavus G. Slaughter, local storekeeper, who in 1855 won the right to name the new town and post office in a card game with his rival, blacksmith Frederick W. Stiman. The post office was established as Slaughtersville on Jan 29, 1856, with Henry A. Prater, postmaster. Slaughter himself served as postmaster from 1860 to 1865 and was succeeded by Stiman. Though the post office was renamed Slaughters in 1915, the town remained Slaughtersville from its incorporation in 1861 until 1967 when the Board on Geographic Names reversed an earlier decision and conformed to common usage and the present name of the post office.
