ROWAN FAMILY BIBLE RECORD

The Rowan Family Bible is in possession of Mrs. Frances Moseley Hoover, Livermore, Ky. Was originally owned by Mrs. Minnie Rowan Moseley, deceased, wife of James Robert Moseley, also deceased, parents of Frances Moseley Hoover (Mrs. Randall Boyd).

William Rowan, second son of Andrew Rowan, was born in Ireland 1735, came to America with his father and married Sara Elizabeth Cooper, died 1800 in Nelson County, Kentucky, William Rowan was a Revolutionary Soldier. Children of William and Elizabeth Rowan:

History of No Creek, Ohio County, Kentucky, by Harry D. Tinsley (Frankfort, KY: Roberts Printing Company, 1953) pp.118-120, "No Creek Family Plots":

The next burial plot is on Charles Whobrey's farm. It is the Rowan plot. There are thirteen simple upright markers of sandstone and marble. The most historical one buried here is Stephen Rowan who was the eldest son of Captain William Rowan, the other two being Andrew and John. The latter became a famous Kentucky jurist and legislator and the builder and, until his death, master of the typical Kentucky mansion, which he called "Federal Hill," now nationally known as the State's shrine, "My Old Kentucky Home," at Bardstown. It was a visit to this home which inspired Stephen Collins Foster, a relative of the Rowans, to write the immortal ballad for which the homestead is named.

Captain William Rowan, for whom the Livermore Chapter of the Daughters of the American Revolution is named, was born in York County, Pennsylvania and was of Scotch-Irish lineage. His wife, born Sara Elizabeth Cooper, was a Quaker. Her parents were wealthy and Captain Rowan amassed a sizeable fortune before the American Revolution but their finances were greatly impaired by their gifts in behalf of their fellow patriots. After serving his state and country

in important offices, he was at the head of a volunteer company going to the front where he remained in service for six months, the period for which the men under his guard had enlisted.

At the close of the American Revolution, in the hope of repairing his shattered fortune, Captain Rowan emigrated to Kentucky, then a district of Virginia, in the wild lands of which, according to the autobiography of his son, Judge John Rowan, written in 1841, "he had, without any knowledge of the laws of Virginia or of the nature of the titles to land in Kentucky, invested the little remnant of his fortune." In October 1782 he set out in a flat-bottomed boat, of which he was the owner, with five families, from the Monongahela River, near the mouth of Redstone Creek, for the Falls of the Ohio River. His family consisted of his wife, his three sons and two daughters.

Judge Rowan recounts: "We expected a voyage of not more than six or seven days." In fact, they did not reach the Ohio Falls until March 1783, the journey having taken about five months, during which many hardships were suffered.

After remaining near the Ohio Falls until April 1784, the Rowans again set sail, with five families, for the "Long Falls of Green River," the site of the present town of Calhoun, but known first as Rhoadsville and then, for many years, as Vienna. Proceeding down the Ohio, the Rowan boats, one for the families and one for the cattle, ran into a party of Indians which threatened to attack the vessels, but were deterred by the watchfulness and show of preparedness of their occupants. This occurred a short distance above "the Yellow Banks," the present Owensboro. At the latter point the women and children and the cattle were landed and proceeded overland, a distance of about 25 miles, to "the long falls," while the boats went on down to the mouth of Green River and up that stream to the same destination, arriving, however, some time after the overland travelers. The emigrants arrived at the Green River falls on May 11, 1784.

Stephen Rowan was born in 1765 and died November 3, 1841. His wife, born Katharine Reed and to whom he was married January 27, 1797, died June 28, 1832. They had five sons, all natives of Ohio County, viz.: Alexander R., Stephen Jr., John, Andrew and William Cooper. Only nine male descendants of Captain William and Stephen Rowan now live in Ohio County, I am informed by my good friend, Richard Ney Rowan, Route 3, who is a great-great-great-grandson of Captain Rowan. The others, bearing the family name, are Ney's son, Joseph Cullen, Sr., the latter's two sons, Joseph C., Jr., and Phillip Dale; the brothers, Shults, Alvis Edward and Claude Rowan; Dannie Edward, son of Alvis Ed, and Douglas Ray, son of Claude.

All these "Rowans by name" are descendants of Dr. Alexander R. Rowan, who was a member of the General Assembly as well as a successful physician. Ney is the grandson of Dr. Rowan's son, Richard Alexander, and the son of Azro V. Alvis Ed, Claude and Shults are the sons of the late Andrew Alexander and Mrs. Rowan who is still living. Their grandfather was John Butler, also a son of Dr. Rowan. Another son of Dr. Rowan's son, Richard A., was Robert Alexander Rowan, deceased, who left no male descendants. His widow lives in Livermore. It is to her I am indebted for the opportunity to consult copies of a biography of Judge Rowan and his uncompleted autobiography, which are in manuscript form. I am also indebted to Ney for the privilege of studying his copy of the Rowan genealogy back to the Scotland of 1543.

There are, of course, quite a number of descendants of Captain Rowan in Ohio County who do not bear the name of Rowan, either because of marriage or of descent on the distaff side.

Also buried in this cemetery are Dr. A. R. Rowan, born Jan. 11, 1798, died July 6, 1878; his wife, America, born July 28, 1810, died March 20, 1865; Andrew J. Rowan, who died April 10, 1852, age 41; Lydia E., wife of John Rowan, died July 24, 1853, aged 39 years 9 months and 6 days; Sarah F., wife of John Rowan, born November 11, 1820, died December 19, 1870, and five children of John Rowan, four by his first wife and one by his second. They all have markers

and range in ages from 2 months to 2 years. Lilla Girtrude, the twin to the late Mrs. Lattie Heflin and daughters of A. R. and America E. (Rowan) Pirtle, born May 8, 1872 and died August 16, 1872, is also buried here. There may be unmarked graves.

Hartford Herald, Hartford, KY, Wednesday, 10 May 1876, p.1:

From Luck's Branch.

Editor Herald: — I believe it is a custom with correspondents to give a description of their cities, towns or localities, so I will try to follow suit. We are situated on Barnett's creek, some eight miles west of Hartford, near the old "trace" leading from the old fort at Hartford to Vienna (now Calhoon). The first settlement this part of the country was made by Stephen Rowan, the father of W. C. and A. R. Rowan. I believe there is no trace or marks of his residence left, except the grave-yard....
