


Black Kentucky Pioneers:

Tunnel Hill Cemetery Ohio County, Ky.

The Tunnel Hill Cemetery is at Echols in Ohio County, Ky. It is on Highway 1245, across from the Echols Post Office. In newspaper death notices and death certificates the cemetery is referred to as the “Tunnel Hill Cemetery”, “Echols Cemetery” and “Echols Colored Cemetery”. In April 2019 the Ohio County Historical Society sponsored a cleaning of the cemetery.

Echols (Ohio): This coal company town is on the Illinois Central Gulf Railroad 1 ¼ miles east of Rockport on the Green River, just north of the present Western Kentucky Parkway, and 8 ½ miles south southwest of Hartford. The town was established in 1874 when a Mr. Echols from Illinois opened the local mine. The post office was established on Nov 2, 1881, with Andrew Duncan, postmaster. Little remains at the original town site. The Echols community is now centered at its present post office on Tunnel Hill, ¾ miles northeast of the original town site. 
ECHOLS BLACK CEMETERY

This cemetery is located on Highway 1245, across from the Echols Post Office. Until recently it was almost impossible to get through the undergrowth. A group of men recently formed a community action group and took for their first project, the cleaning of this cemetery, with help from people who had relatives buried here.

Some of the earliest marked graves are, Margaret Simmons, wife of A. Simmons, 1861-1893, Annie Shultz, 1884-1896, Lydia Short, 1824-1912, John W. Short, 1854-1913. There are many unmarked graves. Bubby Short, who ran the ferry at Rockport and Paradise, and his brother Mose are buried here. Among the marked graves are the names of Short, Hack, Render, Rankins, Maddox, Hines, Farris, Baker and Collins.

ROCKPORT - Linda Moss said she and her relatives for years got to their family cemetery through a point off Kentucky 1245 next to a small general store in the Echols community.

They want the same access point to Tunnel Hill Cemetery, a pre-Civil War site that contains graves of black residents, including slaves, and some American Indians, the Beaver Dam woman said Thursday.

But the store has been gone for about 25 years, and the access point is now part of the front yard of the home of Donald and Kathy Holland.

The Hollands said they don't want people driving across their yard to the cemetery. They said such driving damaged their old septic system about four years ago, forcing them to spend \$3,000 to install a new one.

"We spent a lot of time and money getting the yard to look this way," Kathy Holland said.

The desires of Moss and the Hollands conflicted on Memorial Day, when the Hollands were having a birthday cookout. Moss and several carloads of relatives drove to the cemetery, which comes to within a few yards of the Hollands' backyard porch deck.

Donnie Holland said he told them – angrily, both sides agree – of his displeasure. He later summoned the Kentucky State Police and Ohio County Sheriff's Department to complain about trespassing.

"All we wanted to do was get back to our dad's grave," Moss said of Willie Hunt's marker, which sits on the fringe of the Hollands' back yard.

But Donnie Holland said the main source of his anger was Moss' desire to put in a road.

"We've let them drive until they started talking about a road," he said. "We will put a fence up."

Moss, who wants a road at or near the traditional access point, said her relatives are being denied their right to get to the cemetery.

"All we want is our rightful access," said Moss, whose family is pondering legal action.

County Attorney Greg Hill cited a state attorney general's opinion in noting that access to a cemetery can't legally be denied.

"And it's reasonable access," Hill said. He added, though, that the Tunnel Hill issue "is absolutely a private legal matter."

The traditional access makes it easier for the older relatives to get to the grave sites, Moss said.

Plus, she said, "they (the older relatives) said this was given to them, and they want what is theirs. They're very hurt and upset by this."

Moss said additions to the Hollands' house now sit atop old graves. She and her son Tim Moss said some of the sites have been vandalized.

"Someone's always down here to check on that," Tim Moss said. Family members check on the cemetery as often as twice monthly, he said.

The Hollands deny that their house is on graves or that they want to prevent relatives from going to the cemetery.

"Our biggest problem is driving through the yard," Donnie Holland said. He said they prefer people park in their driveway and walk back to the cemetery.

"We have never denied them access," said Kathy Holland, who said she and her father cleaned much of the cleared-out area after the Hollands moved in in 1987.

The Hollands and a next-door neighbor, Anna Ray Fulkerson, said they would give up part of their respective properties to allow an access road to be built.

Linda Moss, though, said the area is a low-lying spot with sewage around it that would cost too much to build up to form a road.

"Nobody wants to go through somebody's waste to get to the cemetery," she said.

Kathy Holland suggested an access point through Echols Cemetery, which abuts the Hollands' property to the west and Tunnel Hill Cemetery to the south. The Echols Cemetery was the burial place for the community's white residents.

But Linda Moss said her family, which has gained access through the Hollands' other next-door neighbor since Memorial Day, wants its usual access. They have consulted an attorney and are pondering a lawsuit, she said.

"You don't ask permission when the cemetery has been there before he ever existed," she said.



FINDING NATIVE AMERICAN Ancestry

Family looking deeper into heritage

Timothy Redbone Hunt Moss reveled in spending time with his grandfather, Willie Hunt, as a child in Ohio County.

"I thought it was fun and cool to go fishing with my granddad," who was known as "85," he said, a nod to the number Hunt was assigned as a coal miner. "All of us (first-cousins) didn't always go because he would be out there for hours and hours. But I learned a lot from him on those fishing trips."

For Moss, 46, those hours of fishing weren't just about catching food or sport, they also gave him a look into his family's history. After years of trying to find out more, Moss says a DNA test revealed Native American ancestry.

He will host a naming ceremony this month, to name his relatives and in hopes of encouraging them to dig into the past as well. The ceremony, open to the public, will be at 2 p.m. Feb. 25 at Barnes Chapel United Methodist Church, 11 Church St.

"I want everyone to learn their spiritual, native name," said Moss, who deemed himself Redbone in the 1990s. His grandfather called him that. "What's in a name? Power. Your name is who you are."

Aside from his grandfather's stories, and those of his paternal grandmother Marie Mud Turtle Moss, Hunt said trying to identify graves at the old Tunnell Hill cemetery also spawned his interest in family history. The last person buried there was his grandmother, Luella "Sugar" Hunt in 2002.

Some graves date back to the 18th century, though many are unmarked. The antebellum site contains graves of black people, including those who were enslaved, and some Native Americans.

"There's so much history there," said Linda Moss, Timothy Moss' mother. "I'm looking to learn more about my native side."

Moss said his maternal great-grandparents moved to Ohio County from North Carolina, where a small band of Cherokee remained after the Indian Removal Act of 1830. He also identifies as "Blackfoot," as it was common during enslavement for blacks to use the term as a code word for people with direct mixed African and Native American ancestry. A lack of documentation of native tribes and enslaved blacks at the time has made his search more difficult, he said.

Blackfoot, as they are properly known, are not reported to have interacted with Cherokee or other tribes indigenous to Southern states, since they live mostly in the northern plains and Canada.

The family has traveled to east Tennessee and North Carolina to connect with distant relatives, share their stories and find any possible links to their ancestors.

"We're not recognized here, and even some native tribes don't accept us, but we want to represent everything we are," Moss said. He's identified as American Indian on his drivers license. "We're not acknowledged for our heritage because most people just go by looks. But we'll keep trying."
