

Fogle's Papers: A History of Ohio County, Kentucky, McDowell A. Fogle (Hartford, KY: Ohio County Historical Society, Inc., 1981), pp.275-281:

The Mail Must Go Through

Actuated by the interest shown by many Hartfordians in the history of the Hartford Post Office upon the occasion of the dedication, of its new building here, I prepared the following sketch of local postal annals:

With the occupancy last week of the new Hartford post office just completed by its lessor Robert Hudson, according to post office plans and specifications, quite a number of queries have arisen as to local postal history, especially the question as to how long the post office had been located in the quarters just vacated on the southwest corner of Main and Center Streets, now owned by Miss Winifred Simmerman, previously the property of her mother, the late Mrs. Jessie Rowan Simmerman, and their grandfather and father, respectively, Captain James W. Ford.

Answering this major question, the Hartford post office had been located on the ground floor of the above mentioned two-story brick building for forty-four years, having first been located there at the beginning of the first term of Postmaster Ransom B. Martin. This information was kindly given me by his son, Hon. Otto C. Martin, leading Hartford attorney. Records of the post office department show that the exact date upon which Postmaster Martin took office the first time was June 12, 1912, and that he served until February 1, 1916.

"Ranse" Martin, as he was affectionately known, far and wide, was one of the only two Hartford postmasters who served two terms separated in both instances by considerable periods of time. The other local two-term postal head was Judge Alexander B. Baird, about whom more anon. The second term of Postmaster Martin began February 1, 1924, eight years after the close of his first term, and ended with his death November 11, 1933; he being the only local postmaster to die in office in the last seventy-seven years which is as far back as the writer has been able to obtain such data.

Another noteworthy fact brought to mind by the recent moving of the Hartford post office into its new building is that it is the first and, to date, only Ohio County post office building "built new" especially and only for postal purposes under Federal government supervision and according to post office department plans and specifications.

Also a matter of pride to the present postmaster and good fortune to the public, as well as of interest to county historians, is the fact that the present incumbent Forrest P. Bell has served longer as Hartford postmaster than any other person appointed to the position since the local post office was established April 1, 1801. Before becoming postmaster, Mr. Bell was a prominent Hartford attorney, having served a term as county attorney.

Postmaster Bell first joined the Hartford postal staff as acting postmaster on August 25, 1938. He served in that capacity until May 24, 1940, when, having been appointed by the President and confirmed by the Senate, his term in his own right began. So, Mr. Bell has served as postmaster for sixteen years, four months, and four days and as both postmaster and acting postmaster, eighteen years, one month, and three days.

Only three other local postmasters have approached the length of tenure of Postmaster Bell. They are, in addition to Postmaster Martin, whose two terms totaled thirteen years, four months, and twenty-nine days, as follows: Isaac Morton, 1814-1829, the exact duration of his term being fifteen years, three months, and one day; Richard L. Walker, 1829-1845, who served exactly fifteen years, ten months, and twenty-seven days.

Mr. Walker's daughter-in-law, Mrs. Robert D. Walker, lives at the old Walker family home here. Postmaster Isaac Morton was Hartford's first successful large-scale merchant.. His son Captain Preston Morton gave his life for the Union at Shiloh, while another son Lieutenant James S. Morton, who later became a prominent Ohio County physician, fought for the Confederacy. We hope to present some more interesting facts as to the location of Hartford's post office buildings before removal to the Main and Center corner in 1912, the chief clerks under a number of past postmasters and a complete list of the local postmaster personnel since the office first opened over 155 years ago.

As to the location of the Hartford post office previous to its removal to the Main and Center site, I have obtained definite information back to the beginning of the second term of Postmaster Alexander B. Baird in 1885. His first term had been September 5, 1863, to May 30, 1865.

Of the long line of local postmasters from the establishment of the post office here, April 1, 1801, a number of them were merchants. Then, as often since, some of the Hartford postmasters probably had the post office in the store or other place of business owned by them or members of their family. This may have been the case with Postmaster Martin Wickliffe, who, likely, was a relative of Nathaniel Wickliffe, who is reputed to have had the first store in Hartford. It was located on the north-east corner of Main and Center Streets where Brown's Pharmacy is now situated. This old building was burned to celebrate a victory in the War of 1812.

Another abandoned local structure, "the old Crow tavern," was also burned to celebrate the victory of General Jackson at New Orleans. It may have housed the post office when Warner Crow was postmaster since his term began January 1, 1806. This old tavern, presumably on today's local Main Street, was near the store of Isaac Morton and his brothers. The latter was endangered, but not destroyed by fire. It is rather likely that Postmaster Isaac Morton conducted the office in a part of his and his brothers' store. Since Postmaster Richard L. Walker was a merchant, he may have conducted the office in his mercantile establishment.

There is also a tradition that the post office was also once located in the building on the northeast corner of Union Street and McCreery Court, the present home of Mrs. Margaret (Barbour) Williams. This building, probably the oldest in Hartford, was the location of the town's first bank, a branch of the state-established Bank of the Commonwealth of Kentucky which was in operation from 1821 to 1830. The bank was supposedly located in the corner room on the ground floor at the intersection of the two streets. The post office might have been elsewhere in the building which grew to be quite a large structure. Who was postmaster then, there seems no way of ascertaining.

But, we are back on the terra firma of fact when we turn to Judge Alexander B. Baird, who served two terms as postmaster of different lengths and separated by a period of twenty years. His

first term began September 5, 1863, shortly after he had completed two terms as county judge. His first term as postmaster ended May 30, 1865. On April 20, 1885, a Democrat having been on the preceding March 4 for the first time since the War between the States inaugurated as President, the aging publicist again became local postmaster. During this second incumbency the post office, according to Professor U. C. Barnett, A. I. Nail, and A. C. Yeiser, was located in the back part of the ground floor of the two-story brick building on the north-west corner of Center Street and Apple Alley which now houses The News and belongs to Mrs. Tina Landrum, mother of the editor. The front of the ground floor was occupied by a, grocery, but I did not gather whether the postal quarters were entered through the store; from the side street or from the rear.

The next Hartford postmaster was Mrs. Lucy Hubbard, widow of the prominent Hartford lawyer, E. C. Hubbard, and daughter of the distinguished Union commander, Col. Q. C. Shanks. She served from April 3, 1889, until the 28th of the same month and year. Though listed as postmaster, the brevity of her tenure seems conclusive that she was merely acting postmaster. This interim incumbency of Mrs. Hubbard has also been confirmed by informed county historians. Mrs. Hubbard, during her short incumbency, continued the office in the back room of the present News office where it had been under Judge Baird. Postmaster Milligan moved the post office to quarters in the Commercial Hotel on the north-east corner of Main and Center streets where the Brown Pharmacy now is; before a great while, he again moved it---this time to the one-story frame building then on the present site of Ruph's bakery where it continued during the remainder of his term and that of W. H. Griffin. William Mulligan succeeded Mrs. Hubbard; he served from April 29, 1889, until he abandoned the office some four years later, and fled following the death of his step-daughter and post office assistant. He was succeeded by William Henry Griffin on March 18, 1893, following the victory of the Democrats in the presidential election the preceding November when Grover Cleveland was elected to his second term. Postmaster Griffin served until he was succeeded by Woodbury Tinsley, prominent farmer, Union veteran, and Republican leader, on May 19, 1897, following the election of William McKinley, the Republican presidential standardbearer the preceding November.

For awhile following the beginning of Postmaster Tinsley's regime, the post office was continued in the Center Street and Apple Alley building where it had finally been moved by Postmaster Milligan and continued by Postmaster Griffin. Then postal quarters were provided on the ground floor of the two-story brick building almost directly across Main Street from the courthouse, then owned by Mr. Tinsley, now the property of C. C. King and occupied by King's Drug Store which is owned and operated by Mr. King and his son Eugene. A part of this storeroom was also used for mercantile purposes. Bookkeeper and chief clerk for Postmaster Tinsley was Miss Henrietta Guenther, member of one of Hartford's pioneer German families.

The chief clerical tenure of "Miss Hennie", as she was popularly known, also continued for a portion of the term of Musker L. Heavrin, prominent local attorney and G. O. P. leader, who succeeded Postmaster Tinsley March 14, 1907. Also serving in that capacity a portion of the time during Postmaster Heavrin's term was Miss Ira Mills, daughter of Mr. and Mrs. A. W. Mills. She later became the bride of William H. Gillespie, of Hartford; she and her husband are now dead.

During Postmaster Heavrin's term, the post office was located on the ground floor of a two-story frame building belonging to him located on the lot on the south-west side of Main Street between today's Carn Barn Cafe and the Hartford Deposit Bank upon which there is now no building. On the second floor of this building were the owner's law offices, where, if I recall correctly, he and Attorney Ernest M. Woodward, native Ohio countian, but now one of Louisville's

most distinguished barristers, had conducted their legal partnership for some years before the latter removed from Hartford, first to Henderson, I believe, and then to the state metropolis.

On June 12, 1912, the late Ransom B. Martin, father of Judge Otto C. Martin, dean of today's Ohio County bar, who had previously served the public as deputy sheriff and sheriff, was appointed Hartford postmaster to succeed Mr. Heavrin. It was then that the post office was first located in the Ford-Simmerman building on the corner of Main and Center Streets where it remained under all succeeding postmasterships until it was moved a few months ago to its present quarters on Center Street on the site of the former State Highway garage. This new post office building was built specially for that purpose under post office department supervision. During Postmaster Martin's 1912-1916 term, which was the first of his two tenures in that office, he had the efficient and courteous services of his sister-in-law, the late Miss Harriett Flener, as chief clerk and bookkeeper.

Succeeding Postmaster R. P. Martin at the close of his above mentioned term, which was not destined to be his last, was Ernest E. Birkhead, father of H. Kenneth Birkhead, both of whom are still our esteemed fellow citizens. Postmaster Birkhead was for many years one of this city's leading businessmen and served two terms as master commissioner. During his term which began February 1, 1916, and ended February 1, 1919, the post office quarters were retained at the Main and Center site. At various times during his term, Postmaster Birkhead employed as chief clerk and bookkeeper his wife, the former Miss Isabel Cox, and her sister, Mrs. Randall T. Collins, the former Miss Ella Cox, daughters of Captain and Mrs. Samuel K. Cox. Also employed by Postmaster Birkhead in the same capacity for a portion of his term was Mrs. Robert D. Walker, daughter of the late William Berry and Mrs. Gabriella Render.

Ernest E. Birkhead was succeeded by Ozna Shults as acting postmaster on February 1, 1919. Professor Shults served in that capacity until August 20 of the same year. His chief clerk and bookkeeper was his daughter, Miss Corinne. His successor was Judge James Sharp Glenn, prominent Hartford attorney.

Judge Glenn was appointed to the local postmastership by President Woodrow Wilson. His confirmation was of date August 29, 1919, and he served until February 1, 1924, when former Postmaster R. B. Martin was again appointed to the position. Serving in the capacity of chief clerk and bookkeeper under Judge Glenn were his son, James S. Glenn, Jr., and Mrs. Robert D. Walker, the former Miss Ida Render, who had theretofore served in the same capacity for a time under Postmaster Birkhead.

Postmaster Ransom B. Martin's second term began February 1, 1924, when his appointment by President Coolidge was confirmed by the senate. Mrs. Walker continued as chief clerk and bookkeeper under him for a time after which, in succession, that position was filled by Miss Hartley Tinsley, daughter of the late Mr. and Mrs. Elmer Tinsley; Mrs. Annie Laura Baker, daughter of Mr. and Mrs. John Dodson, and Mrs. Minnie Wallace, daughter of the late Mr. and Mrs. Isaac Cooper.

Postmaster Martin's second term ended September 8, 1933, he having resigned on account of ill health; hi death occured some two months later. Incidentally, it seems that no Hartford postmaster has died in office, but Postmaster Woodbury Tinsley, like Postmaster Martin, died only a few months after his term also was terminated by his resignation due to impaired health.

Succeeding Postmaster Martin was Miss Susan K. Yeiser as acting postmaster. She took charge of the office September 8, 1933, and served until November 28, 1934, when Lyman G. Barrett became acting postmaster. "Miss Sue" herself acted as chief clerk and bookkeeper during her incumbency as acting postmaster. She continued in the same clerical and accounting capacity

during the incumbency of Postmaster Barrett both as acting postmaster and after his appointment had been confirmed on February 18, 1935, until his term ended August 25, 1938.

Miss Yeiser also served for a time as chief clerk and bookkeeper under Hon. Forrest P. Bell, local lawyer, who became acting postmaster, as above stated, on August 25, 1938, and whose permanent appointment was confirmed on May 24, 1940. Following Miss Yeiser, Mrs. Josephine Ralph, daughter of Mr. and Mrs. Clarence Pirtle and wife of Hon. Wendell Ralph, former county tax commissioner and state parole officer, has been chief clerk and bookkeeper of the Hartford post office under Postmaster Bell down to the present.

In answer to a number of requests, we again list herein below all of Hartford's postmasters from the establishment of the local post office 156 years ago; the name of each is followed by the date he or she took office:
