I discovered your website while doing some research on my Owensboro ancestor Frank Wecker who is said to have left with Jack Thompson's Confederate Dixie Guards as a drummer boy. I have discovered a lot of information on Frank and his life from the newspaper collection of the Kentucky Room and also a couple of newspaper websites. I was trying to get official proof of his war record in order to attempt to get a military gravestone for his grave. He has no grave marker. Are you available to hire? Frank was captured during the War by Provost Marshall Grissom when he ventured back to Owensboro to visit his family. One article said he was jailed for a while. Since his incarceration would be Union records there might be a chance that some record of his service remains somewhere. Would this be something I could hire you to search for? I also have another Owensboro Kentucky mystery in Martha J. Wilkerson. She was 16 and living alone in Owensboro in 1850. I found several other Wilkerson children from ages 14 down which I believe could be her siblings, living with a Leah Pipes, but, I could never find out anything on who Martha's parents were. She married John Boehm who committed suicide in 1854 which was reported in the newspaper. Martha's ancestry is also something I'd like to find out about as it is a bit of a brick wall. Eric B. The Kentucky Room found the obituaries for the Moseleys, he was prominent as being in charge of roads and for Luvenia which had "Igleheart" in parentheses. So, my mother was right in telling me that when her dad, Albert, was orphaned at age 13, he was raised by "family". The gathering at the time of Luvenia's death in 1920 was at their home on Route # 6 or 7 on the Hartford Road. Do you know if there is a way to learn where that residence/farm? might have been. The Kentucky Room also found that Luvenia's father is buried in "the Igleheart cemetery". Do you know where that is? And can you help me with very specific driving directions to the Brushy Fork Cemetery that is near Guffy? That is where my Great Great Igleheart Grandparents are buried. I have been having

a lot of fun using scraps of black granite and an aluminum sign to create a marker for my Great Grandmother Tresa Ellen Murphey Igleheart's unmarked grave in the Old Brushy Fork Cemetery in Daviess County. Brenda: To discover the location of a property one has to trace the owner's name in the deed (grantee – buyer & grantor – seller) deed indexes in the County Court Clerk's office at the Daviess County Courthouse. The indexes will give the deed book and page a particular deed is recorded in. The actual deed will give a brief description of the property's location. The only description of the location of the Igleheart Cemetery I have is given in the book, "Daviess County, Kentucky Cemeteries, Volume 2" (p.99). The listing states that the William D. Igleheart Cemetery is on Highway 81 near the Mount Pleasant Cumberland Presbyterian Church. The 1876 Daviess County Atlas shows Igleheart's owning land on the west side of the road near the church. Hi I just wanted to send an email after discovering your research titled Black Kentucky Pioneers: Thruston Cabell (c1836-1905). My name is Paul and I live in Wales. Friends of my wife's family are visiting us from California and asked me to look into their family who were from Ireland. In my research I discovered the sister of their ancestor married Alexander Buchanan Barret in 1854 and moved to Kentucky. Alexander Buchanan Barret being the slave owner who purchased Thruston Cabell. The family who I am researching for are totally unaware of their connection to this dark period in American history. One of my own ancestors came to Wales via Canada around the same period of time. He was originally of West African descent and his family presumably had come to America as a slave. I wanted to thank you for your research as it was great to read the story of Thruston Cabell. I am so glad that his life has been shared as the 1850 and 1860 census records don't give the names of the slaves owned by Alexander Buchanan Barret, only their ages, sex and race category. She shared the information that you had gathered on Jeremiah Ezell (sr), and the associated family group sheets. What a treasure to work with such experienced history-genealogy researchers! Leslie also directed me to your website on Western Central Kentucky. I've only just begun to dive into such a huge amount of valuable information. I thought I might offer to share with you the file that I ordered and received from the National Archives. It all concerns the pension and guardianship applications that were filed by Amanda Bratcher/ Baize/ Thomas/ Ezell/

Moody. It is a large file, but I would be glad to share in two batches. It is pretty fascinating as it gives a glimpse of what life was like post Civil War for those who had suffered so much trauma. I truly believe that the impact of PTSD on our society following the Civil War is something that needs to be recognized. Wesley Ezell's headstone is attached to this email. He is buried at Cheek Cemetery in White County, Arkansas. It is a peaceful place surrounded by fields and filled with cedar trees. He is listed as Wagoner Wesley Ezell from the 17th Kentucky Infantry, Co A. I've done a bit of reading about this group and their battles - it is truly amazing that he survived. I've never found much about Wesley until I realized that Wagoner was not his first name, but rather his position within his company. Once I started the revised search, everything started to come together. I am fairly certain that he is the son of Jeremiah Ezell Jr and Elizabeth Keown - John Wesley Ezell. Please correct me if you have anything contradicting that. "Wagoner" Wesley Ezell is buried next to my great great grandfather, James Wesley Ezell. James Wesley was the son of Thomas Ezell and Elizabeth Autry. He came to Arkansas after the War with his small children and after a failed marriage to Sarah White. Sarah, like many women, had been abandoned by her returning husband after the war and was never divorced from him. She proceeded to marry my great great grandfather anyway. James Wesley had been married several times before and my great grandmother Cora Bell Ezell was the daughter of Darcus Miller and James Wesley. Cora married Silas Cox in White county, Arkansas where they farmed and Silas was a cotton broker. Their daughter Myrtle Erie Cox was my grandmother. Apparently the Ezell families remained close to one another. My mother remembered going as a child to Kentucky to visit the Ezell relatives in Horse Branch. My ancestry tree is wide open if you wish to sift through it. I've added as many pictures as I can. Please let me know if anything is incorrect so that I can keep it clean and sources cited. Take anything you like from my tree and I am glad to share those large pension files if you would like to have an electronic copy. Just let me know. Greetings, Mr. Long! I just ran across your book on the Young family, including Martin Young and Margaret Conder. As you say you are a descendant, we are probably distant kin. I am a descendant of Thomas M. Conder, b. ca. 1802 either in NC or KY. Thomas m. Nancy Whittinghill (Whittenhill) in Mercer County, KY, in 1823. They moved to Owen County, IN in 1840, and on to Mclean County, IL, in 1858 or 9. They had a large family. I am descend via their son, Henry G. (for Gabhart, we think, named for Nancy's step-father). The line to me is: Thomas M. Conder, 1802-1865 (wife: Nancy Whittinghill/Whittenhill) - Henry G. Conder, 1829-1887 (wife: Dicy Scott) - Isaac Floyd Conder, 1852-1922 (wife: Emma Mechem) - Oralee Grace Conder Cuthbertson, 1878-1933 (husband: James Edward Cuthbertson) - Floyd Edward Cuthbertson, 1914-1990 (wife: M. Phanetta Gibson) - Kenneth Lee Cuthbertson, b. 1956. My conundrum is the utterly tangled Conder/Condor skein of insufficient data and mis-attributions between ca. 1790 and 1820 in particular. Trying to sort it out, my intuition is that Thomas M. Conder was a son of John "Conter" and Margaret Mock/Mack who were married in Cabarrus County, NC, in 1799, and probably the John Conder who shows up there in the 1800 Census. I think that because I think the "M" in Thomas's name (which does show up in records) probably stands for "Mock" - since Margaret Mock/Mack was most probably the daughter of Thomas Mock who shows up on the same Cabarrus census pages as the Condors (Gonders), Goodnights, etc. How John (listed in the 1755-1774 age range in 1800) fits in with the other Condors is a mystery as well, though I suspect the George and Barbara line. (He's basically in the same vicinity in 1800 occupied by George in the 1790 census, and Peter in the 1810 census.) I've found what I can online of census and marriage records. I've not been quite where I could delve into land records or wills. Burials are elusive. (We're sure that Thomas and Nancy are in the McNaught Cemetery near Gridley, IL, but there's no stone or record for them.) Btw, religiously Thomas's family were strong into the early Christian Church/Disciples of Christ movement as were a number of the Condors and their kin in KY and IN that I've found. Anyway, I thought I'd take a shot and see if any of this rings a bell for things you've run across previously. I'm a retired Presbyterian (PCUSA) minister. I grew up in KS. Dear Jerry, You are very wise! Your Young file is, however, helpful in several ways. I'm extracting some bits into a piece I'm putting together of likely possibilities. I'll send it along when I have it better together. The interesting census bits to me are the fact that George "Gondor" in 1790, John Conder/Condor in 1800, and Peter Conder in 1810 seem to be living at the same property in Cabarrus County, adjoining Christian Goodnight, Thomas Mock, etc. Your chronology of when George likely moved to KY, and later Peter, is helpful. Maybe with John in between. I was already suspecting Martin Young as Margaret's husband, again from the census page and other bits online. I'm very puzzled by

the "excepting" clauses in George Sr.'s will concerning the younger George, and Margaret Young. I wonder if the younger George was not yet of age when the will was drawn up in 1790? And might the exception for Mgt. be due to her gender? Curious. From another piece I've seen reference to, there was a land sale between a George Conder and wife Susanna in 1806: "On Nov. 3, 1806, George and Susanna Conder sold their land in Washington Co., Ky; John Goodnight was a witness. This John Goodnight married Margaret (Peggy) Conder...." (Article submitted by Patricia Hinkle Shemenski: "CONDER - GOODNIGHT", p. 154 of the book "The Heritage of Old Mecklenburg County, North Carolina, 1763-2003," published in 2006 by The Old Mecklenburg County Heritage Book Committee and County Heritage, Inc.) I'm guessing this was the younger George. (I've found no documentation for the widespread attribution that Susanna was a Goodnight, but maybe....). The four children listed in the will are the only ones I'm convinced of. Most online files add Jacob (b. ca. 1772), who lived in Bullitt County in 1810, and is almost certainly the one who shows up in Owen County, IN, from the 1820s on. But, again, no documentation beyond Jacob being listed as born in NC, and lived in KY. Your mention of shifting county boundaries in NC and KY over the years is also helpful. I knew that Cabarrus NC was divided off of Mecklenburg, but it sounds like KY had a lot of shifts. As I said, I'll send my piecework along when I have it better together.... Greetings "cousins!" I'm at least sure enough of that to say it. I'm sending this to three of you who I've interacted on this, and commiserated on the disarray of Conder info. from the end of the 18th into the early 19th centuries. Attached is Part I of the document I've been working on, trying to sort out the various Conders in NC, KY, and IN from that period, the ones most closely related to my ancestral line. I've worked with what verifiable information I could find... including a lot of viewing of digital originals of census entries, marriage bonds, and marriage consent forms (which widowed mothers submitted for their daughters). I've also used reliable-seeming information from other published sources as available. What I've not had is land and will/probate records, unless published in other sources... including information that originates with some of you all. And, not surprisingly, birth, death, and burial records are rather sparse on the ground except for the occasional surviving tombstone. As you see at the end, part two of this will be an updated version of the Thomas M. Conder family genealogy, with three previously "missing" children in that

family. Part III will be a compilation of pertinent Conder-related census entries from 1790 to 1840ish, and up to 1860 in a couple of cases, from NC, KY, TN, IN, and IL. I have tried to maintain the distinction between things I think proven, and those I think likely, possible, or probable from circumstantial evidence (location, association, etc.). No doubt I've got some things wrong, and I am glad to know if you have proof or evidence to the contrary on things in the document. I at least think I'm closer to getting it together than I was previously. I have been appalled at the amount of (undoubtedly well-meaning) information found on the internet, that then takes on a life of its own. Her grandmother, Beatrice Lucille Downs, was the oldest of 10 children born in Paducah, Ky in 1904. They were farmers who lived on Husbands Road, but she became nurse and moved to New York. She never went back except for visits. No one in her family appears to have done any genealogy, which amazes me. Of course her mother and grandmother are all gone now, so there is no one to ask. My wife's mother was convinced they were descendants from Cherokee Indians who walked the trail of tears, but somehow ended up in Paducah. I find both sides of her family, Phelps and Downs, were already in KY long before the trail of tears. So her information wasn't helpful. Again, thank you so much for this! I'm continuing with my wife's tree as far as I can go. Right now it appears Jeremiah Downs came here from England and was a American Revolution patriot; unfortunately the DARs have no records of him. Her Phelps line is very interesting. Her Phelps family may have been the Phelps' at the Siege of Boonesborough in 1778. Although it's hard to make connections to the right families because of the use of names over and over. Is part of that it that later on David Shultz lived in Cromwell, which I believe was also called Shultztown? Do you happen to know much about the Cromwell mining community? Dear Mr. Long, My name is Daniele Celano and I just started as an assistant professor teaching U.S. History at Kentucky Wesleyan College, where I am also spearheading the new Center for American Civics. I am a Civil War historian by training, with a particular focus on slavery, and my dissertation (which I am about to defend!) at the University of Virginia examined wartime emancipation in Kentucky. I stumbled upon your website some time ago while researching the 1862 murder of Willis Field, suspected to have been perpetrated by one of his enslaved men, Elliot, and I cannot begin to tell you how immensely your meticulous research helped my work. Using your transcribed diaries and vital records, for example, I tracked down the entire family of Omar and Sarah (McFarland) Field, all of whom were originally enslaved by Field's father-in-law, Robert McFarland, but separated by his death. At least two of their children, Andrew and John, escaped slavery in Owensboro and enlisted in the USCT at 17 and barely 13 years old. John was initially turned away due to his age, yet was soon accepted at an Evansville Union camp as a "contraband," rather than a soldier. Their parents formally married in 1866 through the Freedmen's Bureau, and the family reunited and lived together between Owensboro/McLean. (They are listed on your McLean freedmen's tax list: Andrew, Joseph, Larkin are 3 sons, and Omar/Sarah the parents. Omar came from NC with the elder McFarland, who was an early Daviess settler from west NC.) While enslaved by McFarland, Sarah desperately attempted to visit her 12 children whenever possible, and she happily spent the rest of her life after emancipation always living with at least one child. John Field lived in Tippecanoe County, IN, until his death at 104 in 1953. Even then, the Fields' siblings remained in close contact. I have contacted Kentucky Deferred Comp and asked about having the donation made from my account when the Required Minimum

Distributions are made in December 2026. They informed me I would need to make the withdrawal which then would be taxed the same as the RMDs. It appears to finalize the donation I need to write a check for the \$10,000 from my checking account. I have more than enough to cover the total in my checking account. Good afternoon, Jerry! Making the charitable contribution by check in 2025 will not provide much of a tax benefit unless you itemize your deductions. You did not itemize your federal deductions in 2024, and it is unlikely you will itemize in 2025 unless there has been a significant change in your Schedule A expenses. You could use the charitable deduction on your 2025 Kentucky return, but for federal tax purposes, there will be no benefit in 2025 if you do not itemize. If you could make a qualified charitable distribution from an IRA account directly to the library, the distribution would not be taxable and would count toward your total required minimum distributions for your IRA. For 2025, it would have to be completed by December 31, 2025. You might prefer to wait until 2026 to make the contribution if you will be paying it from your personal checking account. The One Big Beautiful Bill Act (OBBA) added a new provision that goes into effect after January 1, 2026. It allows non-itemizers to claim a partial deduction on their federal tax returns for charitable contributions. If you take the standard deduction on your 2026 federal tax return, you can also take up to \$1,000 of your total charitable contributions as an additional deduction.
